NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Councils rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

On March 14, 2024 during a Brown Act noticed public meeting, the Harbor Gateway South Neighborhood Council ("HGSNC") board voted 5-0-0 in opposition of TBM Management Group being granted approval for a cannabis retail storefront at 1601 W 190th Street.

The Harbor Gateway has reached Undue Concentration for Cannabis licenses. Also, there are several VERY "Sensitive Uses" in and around the area of the proposed cannabis dispensary.

- 1. Located adjacent and in the same parking area is a children's Sky Zone Trampoline Park on the abutting property to the west at 1625 W 190th Street, Gardena. This trampoline Park is an entertainment venue for families and children. It advertises birthday parties and events for families and children.
- 2. There is an elementary school less than half a mile away (.4 miles away); 186th Street Elementary School located at 1581 W 186th Street.
- 3. There is an existing, open and operating medical marijuana, cannabis dispensary store less than a mile away (.7 miles) at 1115 W 190th Street, "Liberty Beach Cannabis".

We ask the above be taken into consideration and the application not be granted for a Retail Storefront Cannabis dispensary at 1601 West 190th Street.
