My wife, who is a member of FOW friends of wonderland, where my two children attend school in the canyon, attended a Q&A with Councilwoman Raman at the school. Ms. Raman, my wife stated you spoke quite eloquently, and made excellent points. She appreciated your sincere care for our school and the entire region you serve. So thank you. Wonderland has a school-wide program known as the Green Coyotes (coyotes are Wonderland Elementaries Mascot). It teaches our children how important plant life/tree-life are to our local environment.
