Non-Elimination of Vacant Positions

I disagree with the plan to eliminate the current 2000 vacant city positions to shrink the budget gap. This action does nothing to address the problem of understaffing that all city departments complain about as the key issue for not being able to provide basic city services in a timely manner to its stakeholders. Inadequate services are what stakeholders have been dealing with for years and they will continue to bear the brunt in the upcoming years with the elimination of about 20% of city jobs. The city cannot continue with using understaffing as the catchall excuse for not providing services to its taxpayers. Rather, the city's hiring process needs to be streamlined to acquire qualified applicants quicker.

Bureau of Street Lightning

Increase budget and prioritized hardest hit areas without lighting. Copper wire theft is more prevalent in neighborhoods that are adjacent to freeways because these places tend to attract homeless encampments. In addition, these areas are usually underserved communities of color. Pico Union is a prime example; it is surrounded by the 110 and 10 freeways. Hundreds of lights have been out for months due to vandalism in this district, and thousands throughout the city. Furthermore, no lighting has increased crime and accidents. Prioritizing hardest hit areas makes more sense rather than in the order of outages reported.

LA Fire Department

Grant the funding requested by LAFD to increase staffing levels to manage workload and to provide firefighter safety Equipment and for infrastructure repairs and fire station maintenance.

Last fiscal year, LAFD requested funding of \$21M, yet they received only a quarter of that amount. For years, LAFD has been operating with a service gap. With each passing year, the population and density increases, and because of this, LAFD has seen a 55% increase in calls. Sadly, the Fire Department has not grown and remains behind due to lack of funds. In addition, there is a critical issue with its aging fires stations. There are a total of 106 fire stations of which 53 are over 50 years old, 12 over 70 and 4 over 80. So, 65% of LAFD's buildings are in the older category stage which boils down to more maintenance and repairs. A tipping point is on the horizon. The city needs to act sooner than later to address this problem.

Department of Building and Safety in conjunction with the Department of City Planning.

Increase budget for proactive code enforcement. This will also increase city revenue. Years ago, the city implemented PACE (Proactive Code Enforcement) and it worked. Throughout the city, homes were well-kept, streets were clean, vendors obtained proper permits because there was a fine attached to not maintaining properties and or businesses in proper condition.

Bureau of Street Services in conjunction with the Department of Transportation

Increase funding to repair potholes and for the paving and maintenance of major roads, residential streets, and alleys. This includes broken curbs and uplifted sidewalks due to tree roots. In addition, to provide more street calming measures in High Network Injury corridors. Furthermore, hire more staff and inspectors in the Urban Forestry Division to provide enforcement and education regarding protected trees. Highly recommend that the maximum penalties with mandatory fines and replacement for trees lost due to illegal removals be enforced.

Department of Sanitation

Increase funding to address illegal dumping and increase fines for the perpetrators. Cameras, illegal dumping signs, and lighting in alleys is highly recommended in known hot spots.

Department of Recreation and Parks

Increase funding to allow for more park staffing and maintenance of our parks and recreation centers which many Angelenos flock to yearlong but that are especially vital to the more vulnerable population in the summer for heat relief.

Animal Services

Increase budget to hire more veterinarians and support staff, as well as to offer and distribute spay and neuter vouchers to address the overpopulation of stray dogs, cats, and rabbits across the city.

I wanted to commend and thank Mayor Bass not only for her courageous new budget, but also for her unwavering commitment to solving the issue of Homelessness in our City. I also want to applaud her for re-declaring a State of Emergency on Homelessness and for her new appointment of Dr. Etsamaye Agonafer as the first ever Deputy of Homelessness in Los Angeles. As the Mental Health and drug addiction aspects of Homelessness are growing more and more dire every day, this new appointment has given the citizens of Venice great hope that a new focus will be placed on addressing Mental Health and Drug Addiction in our City. We also are hopeful that this appointment of Dr. Agonafer will begin to bridge the enormous gulf that has seemed to exisit between the City and the County in regards to providing these desperately needed services WITHIN our City PSH projects and Homeless Housing units. Kudos to Mayor Bass for choosing to sit on the Board of LHASA and calling for transparency in the County's provision of services for our City. My hope would be that now with Dr. Agonafer as Deputy an even greater effort will be made to coordinate with the County to begin training more and more Mental Health workers and drug addiction specialists so that we can really attack this problem just as emergency triage units were set up immediately after WW2 to shelter and urgently treat patients. It would be my great hope that in the monies being spent in this new budget towards immediate housing, that the costs no longer mostly go to very expensive new building (some HHH units costing up to 1 million dollars a door) but rather to more creative development and repurposing that could be immediately occupied and allow many more so in need on our streets to get Inside to a place with services that could actually turn their lives around and get them back on their feet. We Venetrians remain grateful to Mayor Bass for her Inside Safe program that began here in December of 2023. An enormous encampment of many city blocks that went Inside has remained clear to this day. And we are grateful for her recent appointment of Dr. Agonafer, because our unhoused population in Venice unfortunately has many souls suffering from untreated Mental

Health issues and untreated drug addiction, and it is our great hope that she will collaborate with the County to bring much needed life changing services to our City Housing units to get people help right away. People here in our community see that it is getting worse for our neighbors on the streets, not better. People are very ill on our streets and people are dying on our streets and we desperately need places for them to go to get help. So again thank you to the Mayor from Venice for keeping the fight alive and we truly hope this next year will see a great focus on getting people the help they REALLY need quickly to give them a chance to get back on their feet and on their way to an abundant life!
