For one's reference, I have included the text of the first Amendment below: Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. The creation of "bubble zones" across critical locations serves nothing but to infringe upon the right of the people to peaceably assemble. The text of the bill mentions by prohibiting citizens from approaching citizens with the "purpose of passing a leaflet or handbill, displaying a sign, engaging in protest, education or counseling in the public right-of-way". Are we so scared of education, that we shrink away from the perspectives of others? As an American, I take value in hearing the concerns of my peers. I may not agree with everything I hear, but I undoubtly respect the right of everyone to speak their mind. Nevertheless, I have witnessed certain types of speech to be more permissible than others (as determined by an unknown critera), and this bill serves to further punish the "unpermissible" speech. Criminalizing action near places of worship, healthcare, and education only serves to quash Angelinos from speaking their concerns about the crucial issues affecting contemporary society, such as contentions regarding the genocide in Gaza, access to abortion and women's bodily rights, and the defunding of American public education and safety of students in schools. Protests are not meant to be convienent.
