SUMMARY

On September 20, 2024, the Federal Emergency Management Agency (FEMA) notified the Los Angeles Fire Department (LAFD) of an award of funds from the Fiscal Year 2024 (FY 2024) Port Security Grant Program (PSGP) for Fire Boat Training Using Navigation Simulator. The FY 2024 PSGP will provide a total of \$129,000 in funding for tuition and sworn personnel costs (overtime/backfill) for members to attend the training. The FY 2024 PSGP is a cost-share reimbursement grant. The Federal share of the grant is 75% (\$96,750), with a 25% (\$32,250) cost match provided by the LAFD. The performance period for the FY 2024 PSGP is September 1, 2024 through August 31, 2027.

The purpose of the PSGP funding is to strengthen the nation's critical maritime infrastructure against risks associated with potential terrorist attacks. The FY 2024 PSGP grant will fund tuition and sworn personnel costs for Fire Boat Training Using Navigation Simulator.

RECOMMENDATIONS

That the Board:

1. Forward to the Mayor and the Office of the City Administrative Officer for approval, acceptance and authority to expend FY 2024 Port Security Grant Program funding for training; and Request that the Mayor, subject to the approval of the City Council:
2. Authorize the Fire Chief, Los Angeles Fire Department (LAFD) to:
 - a. Accept the FY2024 Port Security Grant Program funding in the amount up to \$129,000 from the Federal Emergency Management Agency (FEMA);
 - b. Authorize the Fire Department to expend funds up to \$65,000 from LAFD General Fund 100, Department 38, Account 6010 for Tuition; and up to \$64,000 from LAFD General Fund 100, Department 38, Account 1098

Variable Staffing Overtime for staffing backfill/overtime in accordance with the FY 2024 PSGP award from FEMA, for the performance period of September 1, 2024, through to August 31, 2027, and any extension of the performance period granted by FEMA; and authorize the Fire Chief, or designee, to execute any documents necessary to accept the grant on the City's behalf.

- c. Deposit FY2024 PSGP up to \$96,750 in reimbursement grant funds into Fund 335, Department 38, Account to be determined;
3. Authorize the Controller to:
- a. Transfer reimbursement grant funds up to \$48,750 from Fund 335, Department 38, Account TBD to LAFD General Fund 100, Department 38, Account 6010 for Tuition; and up to \$48,000 and Fund 335, Department 38, Account TBD to LAFD General Fund 100, Department 38, Account 1098 Variable Staffing Overtime for personnel costs; upon submission of proper documentation by LAFD of actual costs incurred, subject to the review and approval of the City Administrative Officer (CAO); and,
 - b. Authorize the LAFD to prepare Controller instructions for any technical adjustments, subject to the approval of the CAO, and authorize the Controller to implement the instruction

FISCAL IMPACT

The LAFD will fund the grant-related expenditures of up to \$129,000 associated with the FY 2024 Port Security Grant Program. FEMA will reimburse LAFD the required cost share of up to \$96,750 (75%), with the remaining LAFD cost share amount of up to \$32,250 (25%) to be absorbed by the LAFD General Fund

Article 1 Assurances, Administrative Requirements, Cost Principles, Representations, and Certifications

I. (NEPA) and the Council on Environmental Quality (CEQ) Regulations for Implementing the Procedural Provisions of NEPA, which require recipients to use all practicable means within their authority, and consistent with other essential considerations of national policy, to create and maintain conditions under which people and nature can exist in productive harmony and fulfill the social, economic, and other needs of present and future generations of Americans.

Article 26 Nondiscrimination in Matters Pertaining to Faith-Based Organizations

It is DHS policy to ensure the equal treatment of faith-based organizations in social service programs administered or supported by DHS or its component agencies, enabling those organizations to participate in providing important social services to beneficiaries. Article 30 Procurement of Recovered Materials

The Buy America preference only applies to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. The agency should notify the recipient for information on the process for requesting a waiver from these requirements. (a) When the Federal agency has determined that one of the following exceptions applies, the awarding official may waive the application of the domestic content procurement preference in any case in which the agency determines that: (1) applying the domestic content procurement preference would be inconsistent with the public interest; (2) the types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or (3) the inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25 percent. A request to waive the application of the domestic content procurement preference must be in writing. The agency will provide instructions on the format, contents, and supporting materials required for any waiver request. Waiver requests are subject to public comment periods of no less than 15 days and must be reviewed by the Made in America Office. There may be instances where an award qualifies, in whole or in part, for an existing waiver described at “Buy America” Preference in FEMA Financial Assistance Programs for Infrastructure | FEMA.gov. Definitions The definitions applicable to this term are set forth at 2 C.F.R. § 184.3, the full text of which is incorporated by reference.

- Article 35 SAFECOM**
