This is why I am asking you to Vote NO on the California Kratom Consumer Protection Act. ? Regulation Doesn't Work — Utah Proves It Utah passed the very first KCPA in 2019. I have been taking kratom leaf for 12 years on and off as needed for a painful spine condition that I was diagnosed with at 18 years old. When my chronic pain first started, I was offered opiates and muscle relaxers by my doctors. Even at 18, I knew that I did not want my life revolving around addictive pharmaceutical drugs. I read about a natural tree leaf called kratom on Reddit — one that's been used successfully in eastern parts of the world for hundreds of years. It kept my pain low, it gave me some energy, and I was never a "slave" to kratom — my life did not revolve around it because it benefited me so much. During times that my pain was manageable, I could also go days, weeks, or months without taking it, without feeling any withdrawal symptoms. About four years ago, I was diagnosed with severe and medication-resistant rheumatoid disease. I struggled to do basic tasks for myself like brushing my teeth or preparing food because the fatigue and pain I felt were so intense. During this time, I began to use kratom more consistently, and it allowed me to gain very small parts of my life back. When I found 70H two years ago, it changed everything. It gave me the ability to be independent again. It allowed me to live life with less pain — and unlike kratom alone, 70H lasts longer and helps in more areas of pain and fatigue. I've been using it now for two years, alongside kratom leaf, and it has been absolutely transformative. I am able to work again and contribute to society again!!!! This is just one story. I know countless others who have had experiences so very similar to my own. I've also met people who have completely come off of opiates with the help of 7OH, and then eventually transitioned to kratom alone. These are not isolated cases, these are real people finding safer, sustainable ways to manage their pain and reclaim their entire lives. 



### **Pharmacology**

- More than 40 alkaloids have been identified within the natural kratom leaf.
- · Four are known to be pharmacologically active:
- Mitragynine (66% of total alkaloid content)
  7-hydroxymitragynine (0.02%), and a metabolite of mitragynine
- Speciociliatine Corvnantheidine
- Mitragynine and 7-OH-mitragynine thought to be responsible for psychoactive

### Adverse Effects: Clinical Reports

### Effects of Chronic Use

## **Kratom Toxicity Results**

- CDC linked kratom to 152 deaths between 2016 and 2017. Kratom was determined to be a cause of death for 91/152.
- Polysubstance abuse has been estimated to occur in 87% of
- were attributed solely to mitragynine toxicity.
- 484 drug intoxication-related mortality deaths with positive kratom exposure in Florida from 2020-2021. 36 used kratom as the sole substance.
- Co-using opioids with kratom increased the odds of dying of drug intoxication-related mortality.
- 1,151 deaths (across 38 states) associated with kratom/mitragynine in 2023.

## **Respiratory Depression**

- Respiratory depression is attributed to conversion from mitragynine to 7-OH-mitragynine.
- CYP3A inducers (carbamazepine, phenobarbital, St. John's Wort, etc.) thought to increase the effects of mitragynine.
- Individuals with genetic mutations leading to alterations in levels of activity of metabolizing enzyme ("rapid metabolizers") would have different sensitivities to the effects of kratom.
- · When combined with other sedatives (opioids, benzodiazepines, alcohol), kratom can cause significant CNS depression.



### Mitragynine inhibits the metabolism of the below drugs, causing the drugs to leave the body at a slower rate creating elevated levels with potential toxic effects

### CYP2D6 (strong)

CYP2D6 constitutes up to 2% of hepatic CYP content and is responsible for the metabolism of up to 20% of drugs that undergo biotransformation.

### CYP3A4 (modest)

CYP3A4 is a cytochrome P450 enzyme that's found in the liver, brain, and periphery. It's responsible for metabolizing about 50% of all prescribed drugs.

### CYP2C9 (modest)

Cytochrome P450 2C9 (CYP2C9) is an enzyme in the liver that metabolizes many drugs.

### Glucuronidation by UGT

UGTs are important enzymes that help detoxify drugs and other harmful substances. They also metabolize endogenous compounds like bile acids, steroid hormones, and fatty acids.

I am in full support of banning both substances. My son Benjamin Wilcock died from acute mitragynine intoxication on 9/12/24 at 40 years of age. He took kratom to manage his psoriatic arthritis pain. He was led to believe that it was a safe and healthy alternative to prescription drugs and about as addictive as coffee. This belief cost him his life, and it cost me my oldest child and only son. Regulation will not protect consumers from the dangers of kratom. In fact, it may increase a false sense of safety and create a belief the issues surrounding kratom have been resolved. Currently, kratom does not have a safety profile or standardized dosages. The kratom plant and products are extremely variable. There are over 40 alkaloids in kratom and still not a complete understanding of the two main ones – mitragynine and 7 hydroxymitragynine. There are also numerous public websites and social media videos giving step by step instructions on how to increase the potency of the product with different substances or methods of use. The issues with kratom did not just recently begin in the United States. It has a complex history. Comments for Public Posting: Good afternoon, Chair and Members of the Committee. Thank you for allowing me the opportunity to share my story. My name is Twinkle VanFleet. I am a lifelong Californian, a healthcare advocate, and a patient living with Complex Regional Pain Syndrome, also called Reflex Sympathetic Dystrophy. It is a rare, progressive neuroinflammatory disease so painful that it's nicknamed the "suicide disease." Additionally, I live with multiple chronic illnesses and intractable conditions- both congenital and acquired. I was a compliant pain management patient for 12 years, relying on a spinal cord stimulator and a low dose of prescribed medication. But in 2016, at the height of the CDC opioid recommendations, I was abruptly dismissed from care. My medications were cut off without warning, and I went through dangerous cold-turkey withdrawals from opioids, antidepressants, and anticonvulsants. My stimulator has been broken and unmanaged since. I spiraled into depression, suicidal thoughts, and alcohol misuse just to dull the pain. I felt abandoned by the system. I was held in a psychiatric unit in 2016 and again in 2017 for being a danger to myself. In that darkness, I turned to Kratom. And later, at times of severe flares since March of 2024-7-Hydroxymitragynine, or 7OH. For nearly seven years, Kratom has been my safe and effective daily support. It became my life preserver. It eases my often unbearable chronic pain, helps with narcolepsy, lowers my blood pressure, and most importantly- it gave me enough stability to achieve and maintain seven years of sobriety from alcohol. I have experienced no harmful effects other than increased pain if I skip it. 70H, though more potent, offers additional relief when respected and taken responsibly, much like opioids should be. I do not deny that dependency exists. But dependency is not the same as addiction. Kratom and 7OH, when regulated properly, are far safer than the alternatives patients often turn to when left untreated. That is why I strongly support Consumer Protection establishing product safety through manufacturing standards, accurate labeling, third-party testing, and age restrictions. Regulation protects consumers. Prohibition, on the other hand, would only create unsafe black markets and leave patients like me without options. Kratom and 70H are not luxuries for me- they are lifelines. Some days they allow me to make dinner. Other days they allow me to survive a severe pain

flare. Without them, I don't know if I would still be here to speak with you today. Kratom allows me to be with my grandchildren, 7OH relieves me enough to actually play with them. Please don't ban my blessing. I urge you: choose compassion and safety. Support regulation, not prohibition. Thank you for your time and consideration. It gave me space to address the deeper reasons behind my addiction. I was able to slide my way out of chaotic substance abuse and misuse. ?I have not returned to pain management in over six and a half years. Today, I am no longer trapped. I am a functioning member of society again, a thriving mother, a tax-paying citizen, and a proud first-time grandmother. Most importantly, I am no longer a burden to my kids. I will forever be grateful that I found safe, lab-tested whole-leaf Kratom. I am a chronic pain patient with several chronic pain diagnoses. I've been using kratom for over a decade for pain, sever anxiety and depression. I have been given my mobility back, thanks to this plant. Also, it has saved the lives of my siblings. Both survived fentanyl poisonings/overdoses in 2016. Kratom was found by my brother researching for help to withdraw off of heroin and became sober. My sister had also gotten and remains sober from poly substance addiction. I never thought I would see them sober, however, kratom saved their lives. Kratom (Mitragyna speciosa) is a natural plant in the coffee family, and scientific research increasingly supports its safety and potential benefits when used responsibly. Peer-reviewed studies show that kratom's primary alkaloids, mitragynine and 7-hydroxymitragynine, act as partial opioid receptor agonists, which means they can provide pain-relieving and mood-supportive effects without the high risk of respiratory depression that makes traditional opioids so dangerous. In 2019, a comprehensive review in the journal Drug and Alcohol Dependence concluded that kratom has a much lower potential for abuse and dependence than conventional opioids. Additionally, toxicology data from the U.S. Centers for Disease Control and Prevention (CDC) and the National Institute on Drug Abuse (NIDA) show that kratom-related fatalities almost always involve other substances, not kratom alone. Research from the University of Florida, Columbia University, and Johns Hopkins University has found that many people use kratom as a harm-reduction tool, helping them transition away from opioid or alcohol dependence and manage chronic pain or anxiety without dangerous pharmaceuticals. Surveys published in Substance Use & Misuse and Frontiers in Pharmacology found that the majority of kratom consumers report improved quality of life, reduced withdrawal symptoms, and few significant adverse effects. Given these findings, an outright ban would not only be scientifically unjustified but could also drive people back toward more harmful substances. Instead, I strongly support regulation through the Kratom Consumer Protection Act (KCPA), which would ensure product purity, accurate labeling, and safe access — protecting

consumers while preventing misuse. Science shows that kratom, when used responsibly, is a low-risk botanical with meaningful potential benefits. Please base decisions on data, not fear, and keep kratom legal and regulated for the millions of Americans who depend on it as a safe, natural alternative. However, a percentage-based cap unfairly targets 7-OH while allowing mitragynine products with up to 1,000 mg or more per unit to remain unrestricted. If safety were the true intent, both natural alkaloids should be held to consistent standards. This selective restriction benefits certain large vendors and undermines equal-market fairness and science-based regulation, naturally derived alkaloids and extracts obtained from Mitragyna speciosa — including concentrated or oxidized 7-hydroxymitragynine — are not synthetic when produced through standard extraction or oxidation with food-grade solvents. These are the same processes utilized for mitragynine extracts and do not involve chemical synthesis from non-plant materials Before finding 7oh, my life was a revolving door of drug addictions. I would go from fentanyl dependence, to alcohol dependence, . I had done that for the past nearly 10 years. I was constantly trying to escape sobriety and my life suffered terribly for it. From financial struggles to fighting for my life from overdoses, I was miserable constantly. I had originally found kratom and began using that to get off of fentanyl and it worked for the most part but I would still drink until blackout every single day. Then I heard about 7OH and initially it was the fact that I wouldn't have to swallow spoonfuls of plant matter or fist fulls of capsules that drew me in. From the moment I took the first tablet of 7OH I noticed that any desire to drink or craving for any other substance that I would usually have were completely gone. I had absolutely no desire to consume any other substance at all. This was 14 months ago and I have been alcohol free and clean from all other substances and haven't missed or even so much as thought about using anything else. I'm not going to sav that I could have never done this without 7oh but I would never have been happy or done this without suffering and temptation. I fully support age restrictions & limits on marketing to minors, as well as clear accurate labeling & any health warnings. However, under the current language of this bill, it essentially bans 7-hydroxymitragynine. A 2% cap of alkaloids renders all current products illegal overnight. This 2% language isn't even from known public health advisors, it largely came from big kratom industry lobbyists, with interests in eliminating 7-OH from the competitive marketplace. Kratom & 70H have both been a massive impact in my life. Kratom first came to me in 2012, helping me finally exit a methadone treatment after 8 years. Free of financial burdens, I even purchased my 1st home in 2013. Kratom was great for years, but never fully helped my social anxiety & agoraphobia.
