Re: SB 34 (Richardson) – OPPOSE

Dear Mayor Bass and Members of the Los Angeles City Council:

Thank you for your leadership on behalf of the City of Los Angeles. I write to respectfully request that the City Council not approve a proposed resolution in support of California State Senate Bill 34 (Richardson): Air pollution: South Coast AQMD: mobile sources: Ports of Long Beach and Los Angeles.

South Coast AQMD strongly opposes SB 34. While we share the same goal of supporting goods movement and economic vitality within the Los Angeles region, SB 34 would weaken South Coast AQMD's ability to address the region's largest source of air pollution – port-related emissions – until 2031. By circumventing the local public stakeholder process in terms of addressing air pollution, SB 34 sets a dangerous precedent and slows progress toward meeting clean air standards and protecting the health of our communities throughout the region. We remain committed to working collaboratively with all, including the City of Los Angeles, Legislature, ports, industry, and community stakeholders to advance solutions that balance economic growth with the urgent need to reduce harmful emissions from all sources.

As you know, South Coast AQMD's Board paused Proposed Rule 2304: Commercial Marine Ports (PR 2304), which would require the Ports of Los Angeles and Long Beach to each develop a comprehensive plan for charging and fueling infrastructure to support zero- and near-zero-emission equipment, vehicles, and vessels used in port operations.

The pause on PR 2304 is to undertake collaborative discussions on a draft Cooperative Agreement submitted by the Ports of Los Angeles and Long Beach. These discussions on the draft Cooperative Agreement will include all stakeholders, including community stakeholders. If agreement is not reached on the draft Cooperative Agreement by September 19, South Coast AQMD will move forward with PR 2304 by posting the 75-day package (including a draft socioeconomic analysis). However, in the interest of collaboration, discussions on the draft Cooperative Agreement could continue in parallel with the rulemaking to continue to allow for both options. The goal would be to take the issue to the South Coast AQMD Board for a vote in December.

SB 34 would undermine local authority by imposing mandates that could stifle collaborative efforts to address Port-related air pollution issues through a public process led by local leaders, industry and affected communities. Opposition to SB 34 includes the following organizations:
