The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

The Greater Toluca Lake Neighborhood Council (GTLNC) supports Council File 25-0002-S88 (Blumenthal et al. – Raman) 2025-26 Federal Legislative Program / H.R. 5205 - Airport Noise Reduction Act, with amendments.

We find H.R. 5205 lacking in that the public must have material input which should be given the greatest significance in how aircraft-related noise and pollution are mitigated or eliminated. GTLNC puts residents first, as they are the ones who sustain the greatest adverse impacts, should therefore be heard most prominently and have material weight in options and mitigations of aircraft-related noise and pollution, and the airport's control over users.

H.R. 5205 cites Subchapter II of chapter 475 of title 49, United States Code, Sec. 47535. *Authority of general aviation airports to restrict flights for purposes of implementing aircraft noise limitations:*

(b) Community input. In implementing reasonable accommodations under subsection (a), an owner or operator of a general aviation airport and the Administrator shall take into account input received from individuals or entities in communities surrounding the airport.

This Section (b) proposes that operators of general aviation airports and Administrators of airports provide an opportunity to communities to give input, but are not required to give it any weight or importance. This is inadequate and therefore defective.

GTLNC's support for H.R. 5205 is conditioned on the following amendments:


- Expand the public's right to have a meaningful impact in the process, and we ask that this defect be corrected as the bill develops;
- Enable rapid discussion of specific faster rates of climb (ROCs) to a minimum altitude of 3,000 feet,

- A more equitable distribution of takeoffs over a larger geographical area, and
- Reduction in engine revving above 1,000 feet.
