Honorable Members:

Pursuant to the motion adopted under Council File No. 25-0006-S77, the City Council directed the Office of the City Attorney to submit monthly reports on its efforts to combat unlawful price gouging of rental properties in the aftermath of the January 2025 wildfires in Los Angeles. This monthly report for June 2026 supplements our previous reports, which are available in the above-referenced Council File.

Proposed State Legislation

In October 2025, our office prepared a state legislative proposal to amend California Penal Code Section 396 to clarify portions of the statute and strengthen key provisions in support of future enforcement efforts. On April 14, 2026, Assistant City Attorney Kevin James presented the bill before the state Senate Judiciary Committee, which approved the measure. On April 21, 2026, Mr. James and Deputy City Attorney Alexandra Aurisch presented the bill before the state Senate Public Safety Committee, which also approved the measure. On June 16, 2026, the Assembly Judiciary Committee passed the bill. It will now be heard by the Assembly Public Safety Committee.

Status of LA County Price Gouging Protections

On June 24, 2025, the Los Angeles County Board of Supervisors extended price gouging protections in Los Angeles to July 31, 2025. The Board then further extended protections to August 30, September 30, October 29, November 28, December 28, 2025, January 28, February 27, March 29, April 28 and most recently through and including May 28, 2026.

The Board of Supervisors did not approve a further extension of the County's price-gouging protections. As a result, those protections expired on May 28, 2026. However, the City of Los Angeles has continued its local emergency declaration, and price-gouging protections remain in effect within the City.

Ongoing Matters and Investigations

We recently received a referral alleging price gouging involving a single-family residence in the 90094 zip code. Following a prompt investigation, we identified violations and secured a refund for the tenant totaling \$131,079.30.

The following is an update of ongoing civil litigation and criminal filings:

Civil Litigation:

- People v. Blueground US, Inc., LA Superior Court Case No. 25STCV02951: On February 3, 2025, our office filed a lawsuit against Blueground US, Inc., an entity offering furnished rentals of one month or more, alleging multiple violations of Penal Code section 396(e) and LAMC section 47.12. We recently obtained judgment and a five-year permanent injunction against Blueground prohibiting price gouging and requiring prospective compliance measures designed to safeguard consumers and tenants in future emergencies. The settlement also requires Blueground to provide restitution to all customers who were overcharged in violation of state or local price-gouging laws and to pay \$1.2 million in civil penalties, of which \$1 million will be paid to the City of Los Angeles.
- People v. 911 Housing Solutions, et al., LA Superior Court Case No. 26STCV01422, CASE IS STILL PENDING: On January 9, 2026, our Office filed a lawsuit against 911 Housing Solutions and its owner alleging that this short-term rental housing provider has violated Penal Code section 396(e) and LAMC section 47.12, in connection with the provision of accommodations to various insurance companies' policyholders.

- People v. Airbnb, Inc., LA Superior Court Case No. 25STCV21244, CASE IS STILL PENDING: On July 16, 2025, our Office filed a lawsuit against Airbnb, the online short-term rental platform, alleging in part, that thousands of Airbnb listings were price gouged in violation of both Penal Code section 396(e) and LAMC section 47.12.
- People v. Akiva Nourollah, et al., LA Superior Court Case No. 25STCV07712, CASE IS STILL PENDING: On March 18, 2025, our office filed a lawsuit against a group of individuals and related business entities alleging numerous violations of Penal Code section 396(e) and the City's Home-Sharing Ordinance (LAMC section 12.22 A.32).

Criminal Filings:

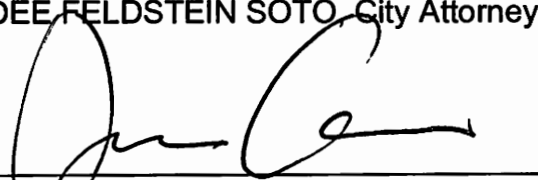
- People v. Cooke & Perry, LA Superior Court Case No. 25CJCM00579: Our Office charged defendants with price gouging a rental property in violation of PC 396(e) and with violating LAMC 45.36(c), the City's Tenant Anti-Harassment Ordinance. The Court granted Judicial Diversion (over the People's objection) which included fines and an order to not harass the victim tenant. On May 27, 2026, the Court determined Judicial Diversion had been completed and dismissed the case pursuant to PC 1001.95.
- People v. Chaves, Chaves Valdes, Chaves & PCAM LLC, LA Superior Court Case No. 25CJCM06980, CASE IS STILL PENDING: Our Office charged defendants with price gouging animal boarding services in violation of PC 396(b).
- People v. Ortega & Gibson Ranch LA LLC, LA Superior Court Case No. 25CJCM06876: Our Office charged defendants with price gouging animal boarding services in violation of PC 396(b). The case was dismissed upon confirmation no victim paid defendants a gouged fee in violation of PC 396.
- People v. Wetline Wildfire Defense, Michael Yakovich, and Adam Lowitz, LA Superior Court Case No. 25CJCM07363, CASE IS STILL PENDING: Our Office charged defendants with price gouging fire protection materials in violation of PC 396(b). The Court granted Judicial Diversion (over the People's objection) which included 40 hours of community service.

We expect the matters in litigation to result in restitution payments to hundreds if not thousands of rent gouging victims, substantial civil penalties paid to the City, and injunctive relief prohibiting future price gouging.
