We encourage you to reach out to the Community Impact Statement Filer to acknowledge receipt and if this Community Impact Statement will be scheduled at a future meeting. Neighborhood Council board members are volunteers and it would be helpful if they received confirmation that you received their CIS.

The CIS process was enabled by the Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Summary: Street lights are a vital means of enhancing safety for all road users. They help drivers navigate in the dark, light the way for pedestrians, and help travelers, especially women and gender minorities, feel safer at night. But too many of them are broken or damaged, and the timelines to get them installed and repaired are far too long. Thus, on behalf of our tens of thousands of stakeholders, the Reseda Neighborhood Council supports the motion's call to review

and eliminate bottlenecks and inefficiencies in street light repair, to collect best practices from elsewhere, and to dedicate more resources towards repair and proactive measures. We are also deeply concerned that many of our streetlamps have been turning purple as the LED bulbs age, which present a health and safety hazard. Lastly, many of our neighborhoods lack street lighting at all and it would be good to be able to find ways to bring lighting into neighborhoods beyond a lighting improvement district.
