I strongly oppose the abuse and killing of dogs and cats. Many are stolen from loving homes - imagine the suffering these people and animals endure. These animals also suffer horrific abuse, including being trucked without food and water in extreme temperatures, before meeting a terrifying, violent death, sometimes being boiled alive. Besides the untold and horrific suffering of animals caught in this gruesome practice, the dog and cat meat trade poses serious public health risks, including rabies and other zoonotic diseases. As you are no doubt aware, the world is still contending with the massively damaging effects of COVID-19. We also are now facing a growing threat from a major Avian Flu epidemic that will dwarf COVID-19 in its scope and lethality, all while -inexplicably - the current administration is cutting resources to fight this threat. Prion diseases are on the rise and can be transmitted from animal to human contact and from eating meat. Just last month a mystery illness in the Congo killed three children; it has since sickened hundreds more with many dying within a 48 hour window of exposure. The illness was traced to eating bushmeat. This is tragic, concerning and unnecessary. Eating animals that are not carefully raised for food and thoroughly screened by food safety officials is a dangerous practice that threatens us all. Any pretext of "cultural" prerogative vanishes in the face of these statistics. Dogs and cats are not food: they often have parasites and traces of medications that are unsafe for human consumption. It is time to end these abusive, risky practices. There is NO REASON ON EARTH that this horror should be allowed to continue. I would like Los Angeles to do what it can to stop the practice.
