ORDINANCE NO. 188710

An ordinance amending Section 5.142 of the Los Angeles Administrative Code relating to the Store Revolving Fund.

THE PEOPLE OF THE CITY OF LOS ANGELES

DO ORDAIN AS FOLLOWS:

Section 1. Section 5.142 of the Los Angeles Administrative Code is amended in its entirety to read as follows:

Sec. 5.142. Creation of Store Revolving Fund.

There is hereby created within the Department of General Services a fund known as the "Store Revolving Fund" hereinafter referred to in this chapter as the "Fund."

(a) Said Fund may be used for the purpose of financing the cost of materials, supplies, equipment, salaries and wages, and necessary expenses in connection with the carrying on of the activities and duties of the Stores Division.

(b) Existing surpluses and encumbrances remaining within the Fund in the amount of \$3.9 million in Fiscal Year 2016-17 revenue may be released to the City Controller. This provision shall sunset at the conclusion of the Fiscal Year 2016-17.

(c) The Controller is authorized to transfer the \$3.9 million from the Fund to the General Fund as 2016-17 revenue. This provision shall sunset at the conclusion of the Fiscal Year 2016-17.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
