Neighborhood Council board members are volunteers and it would be helpful if they received confirmation that you received their CIS.

The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Summary: On May 14, 2025, at a properly-noticed meeting of the Greater Wilshire Neighborhood Council (GWNC), the GWNC board voted to file a community impact statement requesting the Mayor and the City Council to restore the amount annually allocated to Neighborhood Councils to at least the current \$32,000. The GWNC supports the rollover of all unexpended funds from this fiscal year to the next year, as proposed in the Mayor's budget. The GWNC supports the amendment referred to in CF 25-0600-S7, moved by Councilwoman Park and seconded by Councilwoman Padilla, to restore the Neighborhood Council Fund by an increase of \$693,000, thereby restoring each Neighborhood Council's annual budget to the \$32,000.
