Comments for Public Posting: As a mother of a child on the waitlist to attend Downey Child Care, I am deeply concerned that this center—and others operated by Los Angeles Recreation and Parks—may not be operational beyond the end of this fiscal year. This project was funded by a \$20 million grant through the American Rescue Plan Act, which covered the renovation of 10 city child care centers and their first year of operations. It has come to my attention that the Department of Recreation and Parks has submitted a proposed budget to your office, seeking funding to operate only a reduced number of child care centers for fiscal year 2025–2026. According to the proposal, only four centers are included. I find it unjustifiable that such a significant investment in infrastructure was made without ensuring ongoing funding to actually provide services at these locations. According to RAP's own child care site, "as a result of the Great Recession of 2008, Recreation and Parks was forced to close its licensed child care sites due to lack of funding. The COVID-19 crisis highlighted the need for licensed preschool programs. In response to this crisis, our City Council took immediate action by identifying funding to restore and open low-cost licensed preschool facilities." These centers—often located in underserved neighborhoods—are now full of children. The need for affordable, high-quality child care remains as critical today as it was at the height of the pandemic—especially in light of potential inflation driven by upcoming tariffs. I, like many others, was waiting to be able to enroll my child at Downey Child Care as soon as a spot is available At Downey alone, there is currently a waitlist of 53 children. The demand is undeniable. RAP states in its proposed budget that "these variable costs were previously covered by the American Rescue Plan Act funds. It should be noted that RAP was previously directed to self-operate an additional 10 childcare facilities; however, the FY24-25 budget eliminated childcare staffing and directed RAP to operate childcare services through an alternative service delivery model. Therefore, this request is premised on the identification and selection of qualified childcare service providers, which is currently in progress." While there is precedent for the child care budget line to be temporarily set to zero and later reinstated, I do not agree with RAP's assessment or proposed course of action. If the City is unable to continue

subsidizing these centers directly. I urge that alternative funding solutions be presented. Currently, Downey Child Care is only operational due to a grant set to expire at the end of this fiscal year. The proposed budget shows an increase in projected grant funding—have these funds been secured to ensure continuity of services? Downey remains tuition-free, but a fee was intended for families not meeting the financial requirements of the grant program. I ask that the City implement this tuition model, similar to other city child care programs, for applicable families before considering the closure of the center. I have a friend whose child has thrived at Downey Child Care and cannot speak highly enough of the program, its director Allison Tillman, and the dedicated teachers who nurture and support children each day. It is proof that families do not have to pay thousands of dollars each month to access exceptional early childhood education. These publicly run child care centers are essential, safe, and transformative for our communities. I stand in solidarity with other parents whose children attend city-run child care centers and who would also be affected by their closure. I ask for full transparency regarding the future of not only Downey but all RAP-operated centers. Please do not take this vital resource away from the residents of Los Angeles.

WORKING GROUPS, BUDGET DEFICIT, AND COMMAND STAFF CHANGES...

WORKING GROUPS

Over the course of the last several weeks, League Directors, legal staff and our consultant have been working with Command Staff in several Working Groups that Chief McDonnell has commissioned to recommend changes and improvements to Department operations.

These working groups are composed of 5 League Directors and 5 Command Staff members appointed by the COP. The mission of these Working Groups is to recommend improvements to key aspects of the LAPD, including: discipline, minimum patrol staffing, RMEC, crowd control, morale and wellness, use of force, and retention and recruitment.

The League has relied upon input from member surveys, best practices from other like-sized jurisdictions, and direct experiences from Directors and members on how they have been treated by the Department to craft and present proposals to the respective groups.



At the time of this writing (end of March) we are approximately halfway through the process. We will update the membership once these Working Groups issue their final reports.

CITY BUDGET DEFICIT

The CAO has announced a \$1 billion budget deficit. The League is analyzing the current fiscal condition of the City, including its spending on non-public safety programs, its current reserves, and its investment portfolio which is outside of the general fund.

The Board has made clear in a recent member message that we will not agree to any concessions contained in our hard-fought-for contract.

COMMAND STAFF CHANGES

The COP has conveyed to the League that he will be moving some Command Staff members. When those moves will be made is a little unclear, but we, as well as the membership, eagerly await these changes.

Fresh perspectives in key commands are needed to improve morale and point the Department in a new direction. It is our hope that the COP delivers on his mandate for change and installs the right people who have the confidence of the rank and file.
