I am honored to have been a part of the City's most sweeping reforms regarding housing policy to alleviate the present housing affordability crisis. Even where teams have not been cut, the objectives of City Planning will be devastated by a 25% layoff with cascading effects that will slow project pipelines. Don't let the department lose its morale and its future, and its ability implement important new programs like Environmental Protection Measures that will require human eyes for enforcement. Around 50 employees were brought on in the past year alone, and the department devoted much time and resources to training them. With the loss of the youngest and newest members of the workforce (self included), Planning will lose representation of younger generations (many of whom are harder hit by crises such as housing affordability) and alienate future prospects for years to come. It is devastating to see a budget that clear cuts unprecedented progress made not only on housing reform, but also data/GIS, environmental justice, and racial equity. The people of LA fought hard to incorporate these initiatives into the City's work program and deserve policies informed by strong data metrics. The incident with council members making racially disparaging comments only two years ago during an active redistricting session surely indicates that we are not ready to cut racial justice. The state's mandate that environmental justice be addressed as part of the General Plan is especially important in Los Angeles where we can't undo the co-location of residential uses and oil wells — public housing sites like Jordan Downs require 18 feet of remediation. If the City's debt can be blamed on liabilities, its decline and fall can be assured by further lack of oversight. I hope and believe this budget is not an indication of City leadership's priorities, and am optimistic about your work lobbying the state and identifying better solutions in the coming months. From the 1965 Watts Rebellion to the 1992 uprising following the brutal beating of Rodney King, and more recently, the department's violent responses to peaceful protests in 2020, the LAPD has repeatedly demonstrated a pattern of using excessive force instead of serving and protecting. These incidents are not isolated, they are the result of a culture that views Black and Latino neighborhoods and populations as threats rather than citizens deserving care and respect. By continuing to invest such a massive portion of the budget into policing, the city is reinforcing a punitive model of public safety, one that criminalizes poverty and treats social problems as threats to be controlled, rather than challenges to be solved. It sends a clear message that the city is more willing to fund surveillance, incarceration, and violence than to meet people's basic human needs. Meanwhile, thousands of Angelenos live without shelter. Schools remain under-resourced, and many neighborhoods lack access to quality healthcare and mental health services. These gaps in social infrastructure are not accidents, they are direct consequences of policy choices, and budget priorities reflect values. When 47% of the budget goes to policing, what message does that send about whose lives matter and whose do not? There are several significant problems with the proposal to eliminate civilian positions within the LAPD. First, if 403 civilian employee positions are cut from the Department, amounting to 15% of the Department's total civilian staff and 25% of the overall cuts being proposed by the City, sworn police officers will likely have to be utilized to cover the tasks ordinarily performed by civilian staff who normally conduct such duties. Loss of daily functionality in these numbers will, no doubt, have a considerable impact on how the Department is able to conduct other, more critical public safety functions. Second, civilian employees are already scrambling to do more with less, as workforces are generally understaffed and struggling with morale issues on the tails of working through COVID and other challenging circumstances of the past few years. To place an even more significant burden on the civilian staffers who remain is unfair and presents a situation involving an even more stressful work environment for all. And third, terminating this many civilians from LAPD at a time when sworn staff is also struggling with attrition and recruitment just simply does not make logical sense. In an era of trying to bolster the overall numbers of the Department, sworn officers will be confronted with having to do their jobs with even fewer support staff than they have already. Clearly any stringent budget cuts should ideally come from outside the Police Department entirely. Thank you for your consideration of these comments.
