Many shelters do not have enough staff to provide basic care, and without funding for feline enrichment and dedicated staff, cats are often left isolated and stressed, making them less adoptable and more likely to be euthanized. If this budget is passed without amendments, the result will be catastrophic for both dogs and cats: --Continued overcrowding and understaffing, exacerbating already inhumane conditions. --Reduction or elimination of critical enrichment programs that help animals maintain their mental and physical health. -- A likely increase in euthanasia rates, particularly among cats, who already face disproportionately low adoption and high euthanasia rates. -- Closure of shelters, which would displace thousands of animals and devastate communities that rely on those services. 

Mayor Bass unveiled the Fiscal Year 2025-2026 proposed budget cuts on Monday 4/21 and 4 days later an open hearing F 4/25 was scheduled. On the next business day M 4/28, the second open hearing was scheduled. Was there a 10-day public notification for 4/25 and 4/28 meeting in newspaper publications? Also, there was little time between back-to-back public meetings for the public and attendees to review 4 hours of testimony footage to prepare for the second meeting (based on new info gathered). Back-to-back public hearings further compacted timelines for important testimony preparation. Second public hearing 4/28 needs to be one week apart to give time for public review of recorded testimonies and to seek council if needed. The 4/25 meeting was not conducive to a "openly public forum." People's lives are at stake losing jobs, and animals lives hang in the balance. We ask for your consideration at this very difficult time so we can get the information and help we need at these meetings.

Everywhere I turn there is urban decay, including graffiti, which is out of control. I'm embarrassed for the city and can't believe we will host the Olympics. The reporting about our city's condition will be bitter but likely accurate. Meanwhile, housing costs are skyrocketing, and many of us are fearing losing our rent-control apartments because of grifters out to make a buck in this market. I am a progressive Democrat, but it's quite clear that our leaders lack vision and smarts when it comes to running this city. I have little confidence in our mayor's ability to attract business and raise more tax revenue through growth and to solve the homelessness problem. My own councilmember has a very narrow agenda and cares little about the concerns of people outside that agenda. It's just very frustrating.
