These cuts would disproportionately impact some of the City's most essential public health efforts and imperil thousands of Angelenos, particularly those living at the intersection of disability, HIV risk, and substance use. I respectfully urge the Mayor and Council to: -Immediately withdraw the proposed 40 percent reduction to DOD; -Preserve existing HIV prevention and harm reduction contracts; -Before enacting any changes, engage with community stakeholders, including those with lived experience and organizations impacted by the cuts, to gather community feedback and assess the direct effect this funding contributes towards enriching the lives of vulnerable Angelenos; and, -Conduct a formal equity impact review to evaluate the impact and potential long-term poor health outcomes of this reduction. Comments for Public Posting: I am writing to express my deep concerns regarding proposed elimination of funding for day laborer centers in the City of Los Angeles. As a public health professional with over 20 years experience in the field and current director of the UCLA Labor Occupational Safety and Health (LOSH) Program, I have witnessed firsthand the critical functions that these centers fulfill in service of public health and worker safety, often for some of the most vulnerable members of our society. In addition to helping individuals with employment support, these centers are highly trusted resources for training and education, information dissemination, legal assistance, and navigation of public resources. In the earliest days of the COVID-19 pandemic, these centers transformed virtually overnight into sites for distribution of food and supplies to families left without work during business shutdowns; they subsequently became ongoing hubs for COVID-related information, PPE distribution, and successful vaccination drives. Following the January 2025 wildfires, these centers have similarly stepped up to provide much needed information and resources to day laborers who are being hired by property owners and contractors for cleanup and debris removal -often dangerous work requiring advanced training and PPE beyond those needed in more conventional residential work contexts. Indeed, given the enormous demands for workers to carry out the wildfire recovery efforts and the potential worker health catastrophe that could result from day laborers and others being assigned to handle toxic debris without the proper protections, there is perhaps no worse time for the City to consider eliminating funding from these centers. Among other things, moving forward with the proposed funding cuts represents a disinvestment in a vital community-based public health infrastructure whose benefits far exceed the costs for day-to-day maintenance and operations. This short-sighted strategy is likely to have serious consequences for the safety, health, and wellbeing of day laborers, domestic workers, and the broader communities that they serve through their work. I urge the City to reconsider these proposed cuts. Thank you for your consideration.
