We would like to highlight relevant information from Mel Tillekeratne, the director of Shower of Hope, a nonprofit that manages the mobile hygiene program: Employing eight hygiene trailers, the Shower of Hope provided 37,407 showers and bathroom services last year, as well as personal-hygiene supplies. If the budget cut is allowed to stand, these services would disappear, and the trailers would sit unused. Many Angelenos who are employed rely on the mobile showers to get ready for work in the mornings. Many others utilize them to make themselves presentable for job interviews. Moreover, as our Homelessness Study Team, led by Dr. Gina K. Thornburg, stated in its homelessness study report (see
