NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Councils rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

The community of Arleta already experiences cuts in parking enforcement, reduced funding/staffing for Branford Park Recreation Center, plenty of broken sidewalks, has a high number of homeless individuals that are service resistant and continuously remain in place (developing health and public safety hazards on sidewalks and streets for residents and visitors alike) and cause fires and damage and/or theft of both public (e.g. Metro bus shelter glass covers, stolen electricity from traffic poles, etc.) and private property without penalties and/or corrections (e.g. permanent or temporary mental health institutionalization and rehabilitation, accountability, and/or detention), illegal dumping proliferation, no penalization of unpermitted sidewalk vendors nor collection of sales taxes on each of their transactions, and an array of other issues that impact this community and Council District 6.

The Arleta Neighborhood Council opposes a reduction of each neighborhood council's budget going from \$32,000 to \$25,000 for fiscal year 2025-2026, down from the \$50,000 that it used to be in the neighborhood council (NC) system from 1999 to 2008. Not every neighborhood council has free office space and even when it does have office space the leases are very high and take much of an NC's operational costs while storage space for neighborhood council assets is frequently non-existent and requires the storing of such NC assets at a public storage space. The neighborhood council system is a chartered department and reducing both its staff's budget and funding for each certified neighborhood council renders the monitoring of city services as non-existent according to Section 910 of Article IX in the City Charter. This goes against what the neighborhood council system became—a response to an unresponsive City of Los Angeles government to the needs of its taxpayers, particularly to those of the San Fernando Valley, and others alike, that only saw their tax dollars being used for the benefit of Downtown's Civic Center and subsidization of capital-intensive assets *outside of the valley* instead of improving and protecting it and its suburban character, hence, it prompted a secession movement from the City of L.A. back in 2001 after decades long frustrations.

The Arleta Neighborhood Council opposes Council File 25-0600 and any layoff and it requests that the City of Los Angeles Council, the Mayor, and other elected officials explore other avenues that generate revenue such as selling dilapidated or unused municipal real estate, lease municipal office space to interested parties, and consider other ideas not articulated here or elsewhere in the City that save money and protect employed personnel.
