Summary: Our Neighborhood Council asks that the annual budget for Neighborhood Councils remain at \$32,000 and not be reduced by \$7,000. Currently our Administrative costs are over \$21,000 a year, so a reduction to \$25,000 would nearly all be consumed by administrative costs, leaving very little for outreach or Neighborhood Purposes grants or community improvement projects. Additionally, our basic expenses have risen significantly due to inflation while the annual allocation has remained the same for many years now. We ask that the annual budgets for Neighborhood Councils not be reduced.

RE: COMMUNITY IMPACT STATEMENT WITH RESPECT TO COUNCIL FILE 25-0600 – NEIGHBORHOOD COUNCIL FUNDING

Los Angeles City Council Members,

The Northwest San Pedro Neighborhood Council understands the criticality of the City's \$1 billion budget shortfall but ask you to **SUPPORT the neighborhood councils (NCs)** by preserving the current NC budget of **\$32,000** and **OPPOSE Mayor Bass' proposed budget reduction to \$25,000 per NC—a 22% cut.**

- When the NC system was established in 1999, each NC was allocated **\$50,000 (the purchasing power of \$97,321.67 in March 2025)**. In 2009, the City approved a budget reduction to **\$45,000**. When the COVID-19 lockdown took effect, NC budgets were reduced to **\$32,000**. Once the lockdown was over and the City recovered its footing, City-wide department cuts were reversed, excluding the NCs; the **NC budgets were never restored** to their pre-COVID level of \$45,000 per NC.
- For NCs who do not spend their money, these funds are not lost; they revert to the General Fund.
- NCs have operational commitments, including meeting space, minutes, audio visual, storage units or office space, website maintenance, elections and election materials, operational and training expenses (for new board members), outreach materials, etc. Remaining funds are utilized to flesh out the NC system mission—for outreach events, community projects and neighborhood purpose grants, which allow us to give back to our communities and engage with our stakeholders.
- Ninety-nine NCs across the City provide a tremendous service to the 3.8 million (as of 2023) people in the City of Los Angeles. Each of the 1,703 elected members in the NC system takes an oath of office, but we **do the work as volunteers**. Volunteerism doesn't end there as NCs have an additional group of dedicated community members who work on committees.
- NCs engage stakeholders in a way the City Council cannot because we are part of our communities. We work with our council offices, each helping the other to achieve common goals. We work with the mayor's office, our local Chamber of Commerce, as well as City committees, commissions and civil departments, the Los Angeles Police Department and the Los Angeles Fire Department, local businesses, schools and nonprofits. Additionally, **NC members have gone on to become elected officials, valued city employees, appointed advisors, and committee and commission members.**
- **Consider the financial benefit the City receives from 1,703 board members.** Each NWSPNC board member commits to a minimum of approximately 3 hours per week (156 hours per year) of their time. Computed at \$17.81 per hour minimum wage, **the City receives a financial benefit of over \$4,731,547.08 per year from NC volunteerism.**

Current \$32,000 budget	x 99 NCs	= \$3,168,000 annually
1,703 board members	x 156 hours/year x \$17.81/hour	= \$4,731,547.08 annually

It would be a shame to sabotage the efforts of NCs by further reducing our already very lean budget. Therefore, we again urge you to **OPPOSE** this proposed budget reduction and vote no.
