- The entire episode, including the MAYOR gesturing in plaintiff's 111. direction, the Felon Gang member then pointing at plaintiff, walking up to plaintiff and telling her to stop filming "the Mayor" and identifying himself as an El Monte Flores Gang member was all captured by plaintiff via her cell phone video/audio.
- Fearing for her and her husband's safety because of the notorious 112. Flores street gang, plaintiff and her husband immediately left the event that they had paid money to attend.
- To this day, plaintiff remains in fear of her safety given what occurred 113. and that she lives in El Monte.

XIII. THE MAYOR IS NOW EXPLORING WAYS TO ATTEMPT TO KEEP PLAINTIFF FROM ATTENDING CITY EVENTS AND **COMMUNITY GATHERINGS**

- Most recently, following plaintiff's attendance at a memorial service 114. for former deceased Police Chief Ben Lowry, the MAYOR contacted the CITY ATTORNEY and CITY MANAGER.
- The MAYOR has now directed that both come up with a way to keep 115. plaintiff from attending community gatherings and CITY events.
- Ultimately, the retaliation by ANCONA has not and will not stop. 116.
- The MAYOR has proven that there is no limit to what will fuel her 117. revenge tactics against plaintiff.
