BUREAU OF STREET LIGHTING REPORT BACK ON VACANCIES AND TRANSFER OPPORTUNITIES - COUNCIL FILE 25-0660

In response to the Personnel and Hiring Committee's request for a written report on the number of vacancies, transfer opportunities, and the classification of transfers to or from the Bureau of Street Lighting, the Bureau submits the following information, in relation to the citywide layoff avoidance plan (C.F. No. 25-0660).

Layoff Avoidance

Through new position authorities and existing vacancies, the Bureau was able to absorb all filled positions eliminations from the Adopted Budget. We do not anticipate layoffs within the Bureau for Fiscal Year 2025-26.

Budget Information (Position Control)

In Fiscal Year (FY) 2024-25 the Bureau of Street Lighting had a total of 338 authorities (188 regular and 150 resolution). FY 2025-26, the Bureau has a total of 315 authorities (177 regular authorities and 138 resolution authorities).

After new positions are allocated and internal transfers have been made, the summary below is an accurate count of vacancies as of August 1, 2025.
