**Comments for Public Posting:** The City must take action to protect the tenants at 5416-5430 Carlton Way and reject the proposed development at that location. The proposed project would require demolishing seven rent-controlled apartment buildings and evicting hundreds of tenants. The vast majority of these tenants are essential workers in Los Angeles, seniors on fixed incomes, or immigrants who are currently living under the constant threat of ICE terrorism. These tenants will not be able to find other affordable housing in that area if evicted and will likely be displaced from their neighborhood or possibly even the city altogether. Do not put these families and seniors out on the streets just to build yet another luxury apartment building.
