MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations in order to effect settlement in the case entitled <u>Stephen Paper</u>, et al. v. City of Los Angeles, et al., Los Angeles Superior Court Case No. 24VECV03899. (This matter arises from an automobile accident occurring when a Los Angeles Police Department cruiser hit the Papers' vehicle at an intersection, causing significant injuries), **SUBJECT TO THE APPROVAL OF THE MAYOR**:

- 1. AUTHORIZE the City Attorney's Office to expend up to \$18,000,000, to be paid out over three years, in settlement of the above-entitled matter.
- 2. AUTHORIZE the Controller to transfer **\$8,000,000** in Fiscal Year 2025-26 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
- AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009792, Police Liability Payouts, as follows: Panish Shea Ravipudi LLP, Client Trust Account, in the amount of \$8,000,000. Breakdown as follows:
 - a. \$8,000,000 to Panish Shea Ravipudi LLP; Stephen Paper and Richard Paper.
- 4. AUTHORIZE the Controller to transfer \$7,000,000 in Fiscal Year 2026-27, by July 31, 2026, from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
- AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009792, Police Liability Payouts, as follows: Panish Shea Ravipudi LLP, Client Trust Account, in the amount of \$7,000,000. Breakdown as follows:
 - a. \$7,000,000 to Panish Shea Ravipudi LLP; Stephen Paper and Richard Paper.
- AUTHORIZE the Controller to transfer \$3,000,000 in Fiscal Year 2027-28, by July 31, 2027, from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
- AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009792, Police Liability Payouts, as follows: Panish Shea Ravipudi LLP, Client Trust Account, in the amount of \$3,000,000. Breakdown as follows:
 - a. \$3,000,000 to Panish Shea Ravipudi LLP; Stephen Paper and Richard Paper.
- AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.

9. REQUEST the City Attorney to draft a letter of apology on behalf of the Los Angeles Police Department, as requested by the Plaintiffs as part of the settlement.
