Dave Arian Way (Private) – <u>Private Street Name Establishment</u> - Rename Miner Street (Private) from 22nd Street (Private) to its Southerly Terminus to Dave Arian Way

RECOMMENDATIONS:

- A. That the name of the private street, Miner Street (Private) from south of 22nd Street (Private) to its southerly terminus, shown colored red on Exhibit A, be changed, and established as Dave Arian Way (Private Street).
- B. That the Council find that the name establishment is exempt from the California Environmental Quality Act of 1970, pursuant to Article III, Class 5(4) of the City's Environmental Guidelines.

DISCUSSION:

<u>Request</u>: The petitioner, City of Los Angeles – Harbor Department, is requesting the City of Los Angeles to change the existing name of the Miner Street (Private) from 22nd Street (Private) to its southerly terminus, as shown on Exhibit A, to Dave Arian Way (Private).

The Board of Harbor Commissioners adopted Resolution No. 19-8414 on January 10, 2019, approval of Street Name Change along the portion of Miner Street south of 22nd Street to "Dave Arian Way". In the application, Harbor Department stated that the purpose for this name change request is to honor a former Commissioner Dave Arian for his leadership and career.

The Board of Harbor Commissioners approval stated that "On January 2, 2019, while still serving as Vice President of the Board of Harbor Commissioners, Alan David Arian (Dave Arian) passed away after a short battle with cancer. In honor of his leadership and career in the port industry, staff recommends the approval of naming a portion of Miner Street, south of 22nd Street, to "Dave Arian Way". This roadway is within the jurisdiction of the Harbor Department and is defined as a private street within the City of Los Angeles.

Upon adoption of the Report by the City Council, the adjoining property owners and concerned agencies will be notified of the name establishment.
