Neighborhood Council board members are volunteers and it would be helpful if they received confirmation that you received their CIS.

The CIS process was enabled by the Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

We share this information to assist you with the docketing neighborhood council items before your board/commission. If you have questions and/or concerns, please contact the Department of Neighborhood Empowerment at empowerla@lacity.org.

people ICE has detained don't have criminal records and never get their day in court. Instead, they are held indefinitely in for-profit prisons owned by companies who receive massive government contracts from politicians they bribe to keep the cruel operation running. Since June 6, 2025, federal agents have detained over 4,100 individuals in the Greater L.A. area—yet 70% had no criminal record. Many were from schools, workplaces, parks, and faith institutions. One of the most chilling examples: an 18-year-old Reseda Charter High School student was taken by masked agents, simply while walking his dog. Another 15-year-old was detained outside his high school. These are not accidents—they are part of a broader campaign that is tearing at the fabric of our communities. To put it bluntly and clearly, our president has attacked his own country! Reseda Neighborhood Council supports this motion that prohibits LAPD from taking secondary employment with ICE. We also request that the motion be amended to report back on if any current LAPD members have taken secondary employment offers with ICE. MOTION- City Attorney, with support from the **Police Commission**, issue a **REPORT** that leads to a **DRAFT ORDINANCE** requiring LAPD officers to **verify the identity** of any individual claiming to be a law enforcement officer, including Federal, State or Local.

FURTHER MOVE that the Council **REQUEST** the City Attorney, with the assistance of LAPD, to report back on the city's **legal jurisdiction** if it should choose to require other law enforcement agencies to comply with the **draft ordinance** outlined in this motion.

...**FURTHER MOVE** that the City Attorney be requested to **REPORT** on the ability for the City to affirm **a resident’s right to request verifiable identification and legal authority** during any detainment, search, or enforcement action, **especially in any instance involving non-uniformed Or unmarked individuals.**

WHEREAS, on June 7, 2025, the Federal Government **without the consent of the City** or the State announced that it had activated and deployed the California National Guard and United States Marines troops to the Los Angeles area in response to protests and civil unrest resulting from the **immigration raids, leading to further escalation and inflaming tensions** with the local community

WHEREAS, the presidential order marked the first time since 1965 that a **president deployed the National Guard against the wishes of a state's governor;**

WHEREAS, deploying the National Guard and United States Marines in communities that have not requested federal assistance **corrodes morale, damages readiness, undermines local law enforcement,**

BE IT RESOLVED, that by adoption of this Resolution, the City of Los Angeles hereby includes in its 2025-26 Federal Legislative Program, **SUPPORT** for legislation and/or administrative action to initiate the **immediate removal of the United States Marines and National Guard from Los Angeles.**
