An ordinance No. 188748
An ordinance amending Section 10.5.2 of
Article 1 of Chapter 1 of Division 10 of the
Los Angeles Administrative Code
modifying the authority of the Board of
Water and Power Commissioners to enter
into contracts for the purchase of local Water and Power Commissioners to enter into contracts for the purchase of local renewable energy to permit renewable electric generating facilities receiving incentives under the Comprehensive Affordable Multifamily Retrofits Program to enter into agreements authorized by Section 10.5.2.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:
Section 1. Subsection (1)(f) of Section 10.5.2 of Article 1 of Chapter 1 of Division 10 of the Los Angeles Administrative Code is amended to read as follows:

(f) No renewable electric generation facility subject to such contract may receive or have received Los Angeles Department of Water and Power ratepayer-funded on-site generation incentives. Notwithstanding the preceding, a renewable electric receiving incentives.

Department of Water and Power ratepayer-funded on-site generation incentives. Notwithstanding the preceding, a renewable electric generation facility receiving incentives under the Comprehensive Affordable Multifamily Retrofits Program is eligible to enter agreements pursuant to this Section. A renewable electric generation facility combined with an electric energy storage system shall not be prohibited from receiving incentives provided pursuant to a local agency, state, or federal program, including grant programs from such entities administered by the Los Angeles Department of Water and Power. Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
