### Summary:

Immigration and Customs Enforcement (ICE) has conducted operations throughout Los Angeles that have included warrantless raids, community surveillance, and arrests without proper judicial oversight. These operations have caused fear and trauma among residents, particularly immigrant and undocumented communities, regardless of citizenship status. Such actions raise serious concerns about violations of constitutional protections, including the Fourth Amendment right against unreasonable searches and seizures and the Fifth and Fourteenth Amendments guaranteeing due process of law.

The North Westwood community is home to a diverse population, including immigrants (students, workers, residents, and other stakeholders) who contribute significantly to the social, cultural, and economic fabric of the neighborhood. The values of the North Westwood Neighborhood Council include inclusion, equity, and the protection of civil and human rights.

Thus, the North Westwood Neighborhood Council formally condemns ICE operations that violate due process, constitutional protections, and the dignity of individuals residing, working in, and going to school in, as well as visiting, our community. We urge our city officials to investigate and oppose any ICE activities that undermine civil liberties and to provide support and legal resources for affected residents.

To that end, we also:

- Support augmented funding to the RepresentLA program of legal defense for immigration matters
- Call for City advocacy for state and federal bills that limit the collection and distribution of information on individuals' immigration status and that limit improper and unauthorized access and actions of ICE, including State Senate Bill 635, State Assembly Bill 495, State Assembly Bill 49, State Senate Bill 627, State Senate Bill 805, State Senate Bill 48, U.S. Senate Bill 2070, U.S. Senate Bill 2212, and U.S. House Bill 4004 all of which we support

- Oppose any use of City funds to facilitate such ICE activities, including funding of municipal police activities that violate the spirit of the City's sanctuary city ordinance in suppressing legitimate and protected protests and in conducting crowd control that supports ICE

In responding to this crisis, the City Council must remain open and accessible. We oppose any emergency suspension of public participation and the ordinary requirements of the Brown Act.

The North Westwood Neighborhood Council commits to working with local officials to ensure that North Westwood remains a safe and welcoming community for all residents, workers, students and visitors, regardless of immigration status.
