This First Amendment to the Master Memorandum of Understanding (Contract No. 138019) hereinafter referred to as the "MOU", between, the Los Angeles Department of Water and Power, hereinafter referred to as the "LADWP", and the City of Los Angeles, hereinafter referred to as the "City", (including the "City Departments and Bureaus" is entered into with reference to the following:

#### **RECITALS**

**WHEREAS**, LADWP is a proprietary department of the City of Los Angeles organized under the Los Angeles City Charter with a mission to provide clean, reliable water and power to the residents of Los Angeles; and,

**WHEREAS**, the Los Angeles City Charter Section 679(c)(4) provides that LADWP may expend funds for reimbursement to another department or office of the City for services rendered, or materials, supplies or equipment furnished to support LADWP departmental purposes; and,

**WHEREAS**, on October 13, 2020 the LADWP Board of Water and Power Commissioners approved the Master MOU between the LADWP and the City for two years with the option to extend the Master MOU for one additional year for the provision of project delivery services to be completed by City forces; and,

**WHEREAS**, LADWP identified such project delivery services to be completed by City Departments and Bureaus on an as needed or emergency basis;

**WHEREAS**, LADWP has elected to extend the Master MOU for one additional year, in accordance with the extension option clause in the Master MOU, for a cumulative term of three years with the City to allow for the completion of current projects, and the completion of new priority emergency projects which may surface in the third year; and;

**WHEREAS**, the Los Angeles Administrative Code (LAAC) Section 10.5 (e) provides authority to LADWP to enter into contracts for a period up to five years, and LAAC Section 10.5 (a)(1) excludes contracts with other governmental agencies longer than three years from the requirement to first seek City Council approval. As such LADWP has determined that an additional two year extension is desirous for a maximum term of five years for additional project services, as necessary.

**WHEREAS**, the City can, and is willing to, provide the project delivery services to assist LADWP;

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the Parties hereby agree as follows

#### 1. TERMS OF AGREEMENT

The Term of this Agreement will be extended for three additional years, for a cumulative total period of five years, beginning on the date of execution by the authorized representatives of the City and LADWP.

### 2. PARTIES TO THE AGREEMENT

3. Amend Section 5 – General Terms – Roles and Responsibilities

Pursuant to Section 5 of the Master MOU, additional departments, bureaus and services may be added depending on the needs of LADWP:

• Add the Bureau of Engineering (BOE): Architectural Design Services as a project delivery services.
