## **RECOMMENDATIONS**

That the Council, subject to the approval of the Mayor:

- 1. Authorize the Chief of Police, or designee, to:
  - a. Retroactively apply for, negotiate and accept the grant award of \$960,276 relative to the Fiscal Year (FY) 2025-26 Cannabis Tax Fund Grant Program (CTFGP) Law Enforcement from the State of California, California Highway Patrol (CHP), for the period of July 1, 2025 through June 30, 2026 and execute any documents or agreements necessary to accept the grant funds, subject to the approval by the City Attorney as to form;
  - b. Negotiate and execute a Professional Services Agreement with one selected vendor for a term of one year within the applicable grant performance period, for a sum not to exceed \$30,000, for the provision of phlebotomist services as it relates to the grant program, subject to the approval of the City Attorney as to form;
- 2. Authorize the Los Angeles Police Department (LAPD) to:
  - a. Spend up to \$960,276 in funding in accordance with the grant award agreement;
  - b. Submit grant reimbursement requests to the grantor and deposit the FY 2025-26 CTFGP Law Enforcement grant receipts into the Police Department Grant Fund No. 339, Department No. 70, account number to be determined; and,

c. Prepare Controller instructions for any technical adjustments as necessary to implement Mayor and Council intentions, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions:

# 3. Authorize the Controller to:

- a. Establish a grant receivable and appropriate up to \$960,276 within the Police Department Grant Fund No. 339, Department No. 70, account number to be determined, for disbursement of the FY 2025-26 CTFGP – Law Enforcement grant funds; and,
- b. Increase appropriations on an as-needed basis from the Police Department Grant Fund No. 339, Department No. 70, account number to be determined, to Fund No. 100, Department No. 70, account numbers and amounts, as follows:

#### BACKGROUND - REVISED REPORT

On October 17, 2025, this Office released a report concurrently to the Mayor and the Council, relative to the Fiscal Year 2025-26 Cannabis Tax Fund Grant Program – Law Enforcement, provided through the State of California - California Highway Patrol. The original report was released to both the Mayor and Council inadvertently, rather than initially to the Mayor's Office only, in accordance with the contract review provisions of Executive Directive No. 3. The report also omitted the corresponding transmittal from the Board of Police Commissioners, dated August 12, 2025. The revised report herein for Mayor and Council consideration has not changed and now includes the Board transmittal as an attachment.

#### SUMMARY

The Los Angeles Police Department (LAPD) is seeking retroactive approval to apply for and accept a \$960,276.00 grant award for the Fiscal Year (FY) 2025-26 Cannabis Tax Fund Grant Program (CTFGP) – Law Enforcement, from the California Highway Patrol (CHP). The grant covers the period from July 1, 2025 through June 30, 2026.

The CHP's CTFGP – Law Enforcement, administered by the CHP, supports education, prevention, and enforcement initiatives related to impaired driving involving alcohol, cannabis, and other substances. For FY 2025-26, this funding opportunity is extended to law enforcement agencies to enhance public education on impaired driving, enforce related laws, provide officer training, and develop new strategies to combat impaired driving. The grant opportunity focuses on public education and outreach, targeted enforcement of Driving Under the Influence (DUI) and

Driving Under the Influence of Drugs (DUID), and specialized officer training designed to identify and remove impaired drivers from the roadway.

The LAPD Traffic Group has been awarded \$960,276 to implement the DUI Apprehension Program. The proposed program aims to enhance the quality of DUI and DUID investigations and enforcement efforts and enforcement through specialized training for LAPD personnel. The objectives of the grant will be achieved by (1) Expanding officer training; (2) Updating equipment; (3) Increasing enforcement operations on dates and in areas impaired driving is expected to be more prevalent; and (4) Conducting outreach within the business community.

Grant funds will be allocated to provide officers with training and certifications in various courses focused on the detection, deterrence, and arrest of DUI and DUID offenders. These courses will emphasize preventative strategies such as routine patrols, sobriety checkpoints, raising public awareness, and promoting compliance with DUI and DUID laws. The grant program will support enforcement efforts during specific high-risk dates—such as April 20th (4/20)—and events commonly associated with increased impaired driving activity. The grant will also provide for community and business outreach, with a particular focus on educating marijuana dispensary owners. In addition, the grant will support staff attendance at the 2025 International Association of Chiefs of Police Training Conference on Drugs, Alcohol, and Impaired Driving held in Denver, Colorado and the 2025 California Narcotics Officers' Association Annual Training Institute held in San Diego.

Under the terms of the grant agreement, the State will reimburse the City for eligible program expenses as provided in the table below.

A Professional Services Agreement will be executed with a phlebotomy service provider to perform blood withdrawals from individuals arrested during Drug Recognition Expert Certification Task Force operations conducted throughout the grant performance period. The contract amount will not exceed \$30,000 and the Department will select the vendor through a competitive bid process. Grant funds for FY 2025-26 CTFGP – Law Enforcement will also reimburse related costs for eligible sworn and civilian overtime, calculated in accordance with Cost Allocation Plan 42 rates.

In accordance with Los Angeles Administrative Code Section 14.6 - Approval of Grant Applications, Mayor and Council approval is required before accepting and receiving the grant award.

# FISCAL IMPACT STATEMENT

Approval of the recommendations stated in this report will authorize the Los Angeles Police Department to retroactively accept the Fiscal Year (FY) 2025-26 Cannabis Tax Fund Grant Program – Law Enforcement grant award of \$960,276 from the State of California, California Highway Patrol, for a one-year term beginning July 1, 2025 through June 30, 2026. No matching funds are required for this grant. Cost Allocation Plan 42 indirect cost rates for grant-eligible overtime and related costs (\$73,764.24) in support of this program will also be reimbursed with the grant funds for FY 2025-26.

# FINANCIAL POLICIES STATEMENT

The recommendations provided in this report are in compliance with the City's Financial Policies in that all grant-eligible costs are fully funded by the grant program award.

AUTHORIZE the Chief of Police, or designee, to execute Professional Services Agreement(s) with selected vendor(s) for a term of one year within the applicable grant performance period, for a sum not to exceed \$30,000, for the provision of phlebotomist services as it relates to the grant program, subject to the approval of the City Attorney as to form;
  - D. AUTHORIZE the Los Angeles Police Department (LAPD) to spend up to the grant amount of \$960,276 in accordance with the grant award agreement, submit grant reimbursement requests to the grantor, and deposit the FY 2025-26 CTFGP - Law

Enforcement grant funds into the Police Department Grant Fund No. 339, Department No. 70, account number to be determined;

# **DISCUSSION**

The LAPD is seeking retroactive approval to apply for and accept an \$960,276 grant award for the FY 2025-26 CTFGP – Law Enforcement, from the CHP for the period of July 1, 2025 through June 30, 2026.

The CHP's CTFGP – Law Enforcement provides education, prevention, and enforcement of impaired driving laws related to driving under the influence of alcohol and other drugs, including cannabis. For FY 2025-26, the CHP has extended the funding opportunity to law enforcement agencies to educate the public regarding the dangers of impaired driving, enforce impaired driving laws on the roadway, improve the agency's effectiveness through training, and develop new strategies. The grant opportunity focuses on providing public education and outreach, Driving Under the Influence (DUI)/Driving Under the Influence of Drugs (DUID) enforcement efforts, and Officer Training focused on detecting and removing impaired drivers from the roadway.

The LAPD Traffic Group was awarded \$960,276 to implement the DUI Apprehension Program. The proposed program will focus on providing training to personnel to improve the quality of DUI and DUID investigations and enforcement efforts. The grant program objectives will be met by increasing officer training, increasing enforcement operations on dates and at locations where driving under the influence of drugs will be prevalent, and conducting business community outreach.

The grant funds will be used to provide officer training in the following courses: Impaired Driver Apprehension Program; Advanced Roadside Impaired Driving Enforcement; Drug Recognition Expert (DRE) Certification; DRE Recertification; DRE Instructor courses. The training courses will be conducted by current LAPD officers and DRE task forces on an overtime basis. The grant will also be used for High Visibility Enforcement task forces for focused enforcement efforts on identified dates (e.g., April 20<sup>th</sup>, commonly referred to as 420) and at events prone to the use of cannabis. Additionally, the program will support attendance of the 2025 International Association of Chiefs of Police Training Conference on Drugs, Alcohol, and Impaired Driving and the 2025 California Narcotics Officers' Association Annual Training Institute. Lastly, the program will provide business outreach by educating the owners of marijuana dispensaries. Under the grant agreement, the State will reimburse the City for expenses incurred as follows:

Professional Services Agreement(s) will be executed with phlebotomy service provider(s) to draw and collect blood samples from individuals arrested during DRE Certification Task Force actions throughout the grant performance period for an amount not to exceed \$30,000. The Department will select the vendor using a competitive bid process.

Related costs under Cost Allocation Plan 42 rates for grant-eligible sworn and civilian overtime in support of this program will also be reimbursed with the grant funds for FY 2025-26.

Grantee shall comply with the California Code of Regulations, Title 13, Division 2, Chapter 13 Section 1890, et seq. and all other Terms and Conditions noted in this Grant Agreement. Failure by the Grantee to comply may result in the termination of this Grant Agreement by the California Highway Patrol (hereafter referred to as State). The State will have no obligation to reimburse the Grantee for any additional costs once the Grant Agreement has been terminated.

#### A. EXECUTION

- 1. The State (the California Highway Patrol) hereby awards, to the Grantee, the sum of money stated on page one of this Grant Agreement. This funding is awarded to the Grantee to carry out the Project set forth in the Project Description and the terms and conditions set forth in this Grant Agreement.
- 2. The funding for this Grant Agreement is allocated pursuant to California Revenue and Taxation Code Section 34019(f)(3)(B). The Grantee agrees that the State's obligation to pay any sum under this Grant Agreement is contingent upon availability of funds disbursed from the California Cannabis Tax Fund to the State. If there is insufficient funding, the State shall have the option to either: 1) terminate this Grant Agreement; whereby, no party shall have any further obligations or liabilities under this Grant Agreement, or 2) negotiate a Grant Agreement Amendment to reduce the grant award and scope of work to be provided under this Grant Agreement.
- 3. The Grantee is not to commence or proceed with any work in advance of receiving notice that the Grant Agreement is approved. Any work performed by the Grantee in advance of the date of approval by the State shall be deemed volunteer work and will not be reimbursed by the State.
- 4. The Grantee agrees to provide any additional funding, beyond what the State has agreed to provide, pursuant to this Grant Agreement, and necessary to complete or carry out the Project, as described in this Grant Agreement. Any modification or alteration of this Grant Agreement, as set forth in the Grant Application submitted by the Grantee and on file with the State, must be submitted in writing thirty (30) calendar days in advance to the State for approval.
- 5. The Grantee agrees to complete the Project within the timeframe indicated in the Project Performance Period, which is on page one of this Grant Agreement.

#### B. PROJECT ADMINISTRATION

- 1. The Grantee shall submit all reimbursements, progress, performance, and/or other required reports concerning the status of work performed in furtherance of this Grant Agreement on a quarterly basis, or as requested by the State.
- The Grantee shall provide the State with a final report showing all Project expenditures, which
  includes all State and any other Project funding expended, within sixty (60) calendar days
  after completion of this Grant Agreement.
- 3. The Grantee shall ensure all equipment which is purchased, maintained, operated, and/or developed is available for inspection by the State.
- 4. Equipment purchased through this Grant Agreement shall be used for the education, prevention, and enforcement of impaired driving laws, unless the Grantee is funding a portion of the purchased price not dedicated to impaired driving and that portion is not part of the Project costs. Equipment purchased under this Grant Agreement must only be used for approved Project-related purposes, unless otherwise approved by the State in writing.
- 5. Prior to disposition of equipment acquired under this Grant Agreement, the Grantee shall notify the State via e-mail, and by telephone, by calling the California Highway Patrol, Impaired Driving Section, Cannabis Grants Unit at (916) 843-4360.

#### C. PROJECT TERMINATION

- Grantee or the State may terminate this Grant Agreement at any time prior to the commencement of the Project. Once the Project has commenced, this Grant Agreement may only be terminated if the party withdrawing provides thirty (30) calendar days written notice of their intent to withdraw.
  - a. If by reason of force majeure the performance hereunder is delayed or prevented, then the term end date may be extended by mutual consent for the same amount of time of such delay or prevention. The term "force majeure" shall mean any fire, flood, earthquake, or public disaster, strike, labor dispute or unrest, embargo, riot, war, insurrection or civil unrest, any act of God, any act of legally constituted authority, or any other cause beyond the Grantee's control which would excuse the Grantee's performance as a matter of law.
  - b. Grantee agrees to provide written notice of an event of force majeure under this Grant Agreement within ten (10) calendar days of the commencement of such event, and within ten (10) calendar days after the termination of such event, unless the force majeure prohibits Grantee from reasonably giving notice within this period. Grantee will give such notice at the earliest possible time following the event of force majeure.
- 2. Any violations of law committed by the Grantee, misrepresentations of Project information by the Grantee to the State, submission of falsified documents by the Grantee to the State, or failure to provide records by the Grantee to the State when requested for audit or site visit purposes may be cause for termination. If the Project is terminated for the reasons described in this paragraph, the State will have no obligation to reimburse the Grantee for any additional costs once the Grant Agreement has been terminated.
- 3. The State may terminate this Grant Agreement and be relieved of any payments should the Grantee fail to perform the requirements of this Grant Agreement at the time and in the manner herein provided. Furthermore, the Grantee, upon termination, shall return grant funds not expended by the Grantee as of the date of termination.
- 4. If this Grant Agreement is terminated, the State may choose to exclude the Grantee from future Grant Opportunities.

# D. FINANCIAL RECORDS

1. The Grantee agrees the State, or their designated representative, shall have the right to review and to copy all records and supporting documentation pertaining to the performance of this Grant Agreement. Grantee agrees to maintain such records for possible audit for a minimum of five (5) years after final payment, unless a longer period of records retention is stipulated or required by law. Grantee agrees to allow the auditor(s) access to such records during normal business hours and to allow interviews of any employees who might reasonably have information related to such records. Furthermore, the Grantee agrees to include a similar right for the State to audit all records and interview staff in any subcontract related to performance of this Grant Agreement.

#### E. HOLD HARMLESS

1. The Grantee agrees to indemnify, defend, and save harmless the State, its officials, agents and employees from any and all claims and losses accruing or resulting to any and all Grantee's staff, contractors, subcontractors, suppliers, and other person, firm or corporation furnishing or supplying work services, materials, or supplies in connection with the performance of this Grant Agreement, and from any and all claims and losses accruing or resulting to any person, agency, firm, corporation who may be injured or damaged by the Grantee in performance of this Grant Agreement.

#### F. NONDISCRIMINATION

1. The Grantee agrees to comply with State and federal laws outlawing discrimination, including, but not limited to, those prohibiting discrimination because of sex, race, color, ancestry, religion, creed, national origin, physical disability (including HIV and AIDS), mental disability, medical condition (including cancer or genetic characteristics), sexual orientation, political affiliation, position in a labor dispute, age, marital status, and denial of statutorily-required employment-related leave. (GC 12990 [a-f] and CCR, Title 2, Section 8103.)

# G. AMERICANS WITH DISABILITIES ACT

 The Grantee assures the State it complies with the Americans with Disabilities Act (ADA) of 1990, which prohibits discrimination on the basis of disability, as well as all applicable regulations and guidelines issued pursuant to the ADA. (42 U.S.C. 12101 et seq.)

#### H. DRUG-FREE WORKPLACE

- 1. The Grantee shall comply with the requirements of the Drug-Free Workplace Act of 1990 and will provide a drug-free workplace by taking the following actions:
  - a. Publish a statement notifying employees that unlawful manufacture, distribution, dispensation, possession, or use of a controlled substance is prohibited and specifying actions to be taken against employees for violations.
  - b. Establish a Drug-Free Awareness Program to inform employees about:
    - i. The dangers of drug abuse in the workplace.
    - ii. The person's or Organization/Agency's policy of maintaining a drug-free workplace.
    - iii. Any available counseling, rehabilitation, and employee assistance programs.
    - iv. Penalties that may be imposed upon employees for drug abuse violations.
  - c. Every employee who works on the Project will:
    - i. Receive a copy of the company's drug-free workplace policy statement.
    - ii. Agree to abide by the terms of the company's statement as a condition of employment on the Grant Agreement.
- Failure to comply with these requirements may result in suspension of payments under this Grant Agreement, or termination of this Grant Agreement, or both, and Grantee may be ineligible for award of any future Grant Agreements if the department determines that any of the following has occurred:
  - a. The Grantee has made false certification or violated the certification by failing to carry out the requirements, as noted above. (GC 8350 et seq.)

# I. LAW ENFORCEMENT AGENCIES

 All law enforcement Organization/Agency/Agency Grantees shall comply with California law regarding racial profiling. Specifically, law enforcement Organization/Agency/Agency Grantees shall not engage in the act of racial profiling, as defined in California Penal Code Section 13519.4.

Such activities include both direct and indirect (e.g., "grassroots") lobbying activities, with one exception. This does not preclude a state official, whose salary is supported by this Grant Agreement, from engaging in direct communications with the state or local legislative officials, in accordance with customary state and/or local practice.

#### M REPRESENTATION AND WARRANTIES

- 1. The Grantee represents and warrants that:

If the Grantee subcontracts with a Nonprofit as part of this Grant Agreement, the Grantee shall ensure the Nonprofit will maintain its "Active" status with the California Secretary of State, maintain its "Current" status with the California Attorney General's Registry of Charitable Trusts, and maintain its federal and State of California tax-exempt status.

Oral Fluid Drug Screening Devices and Cannabis/Marijuana Breath Testing Equipment The Grantee agrees to ensure all personnel using road-side drug testing equipment, including oral fluid drug testing devices and/or cannabis/marijuana breath testing devices, purchased with grant funds from this Grant Agreement, are trained to recognize alcohol and drug impairment. At a minimum, personnel using these devices should receive Standardized Field Sobriety Testing training. These personnel are also encouraged to attend Advanced Roadside Impaired Driving Enforcement and Drug Recognition Evaluator training. Prior to using these devices, the Grantee agrees to obtain permission from their local prosecutor's office, establish a policy ensuring appropriate use, and require the staff using these devices to receive appropriate training, which may include training from the manufacturer. This will help ensure the equipment is used appropriately. The Grantee shall advise the State (California Highway Patrol, Impaired Driving Section, Cannabis Grants Unit) of any legal challenges or other items of significance that may affect the use or legal acceptance of these devices. Additionally, the State may request additional information about the performance of these devices, including information about their use, accuracy, and feedback from personnel using the devices.
  - b. Law Enforcement Vehicles The Grantee agrees any law enforcement vehicles purchased with Grant funds, from this Grant Agreement, will be primarily used for the enforcement of driving under the influence laws and/or providing public education, related to the dangers of driving under the influence. Additionally, any vehicle purchased using funds from this Grant Agreement shall comply with all California Vehicle Code and California Code of Regulation requirements. The State may require the Grantee to mark these vehicles with a decal and/or emblem, indicating the vehicle is used for driving under the influence enforcement.

# **Project Description**

The City of Los Angeles (City) continues to be plagued by irresponsible community members who drive while impaired. The number of community members who are driving while under the influence of cannabis has increased substantially. This was the result of the legalization of marijuana for recreational purposes in 2016. Research conducted by the National Highway Traffic Safety Administration (NHTSA) indicates drug prevalence is "on the rise among drivers." A 2020 NHTSA study of seriously or fatally injured road users concluded the overall prevalence of alcohol, cannabis and opioids is on the increase. The Los Angeles Police LAPD (LAPD or LAPD) recognizes that a multi-strategy approach of increased training, community outreach, and enforcement is critical in the battle to confront impaired driving. Through community outreach, enforcement and training, the LAPD has the ability to enact strategies to save lives and increase the safety of all road users in the City of Los Angeles. Together, these strategies will reduce the threat of impaired driving and enhance public safety by ensuring all road users are safe while traveling through the City of Los Angeles.

# **Problem Statement & Proposed Solution**

#### PROBLEM STATEMENT

The City has a population of approximately four million community members and covers 468 square miles. Within the City, there are approximately 7,500 miles of street, 11,000 miles of sidewalks, and 40,000 intersections. The City continues to face challenges with community members who are unsafely driving a motor vehicle and driving under the influence.

#### TRAFFIC CRASHES

Last year, the LAPD reported that in 2023 the number of traffic fatalities had surpassed the number of homicides for the first time in 50 years. Unfortunately, the number of traffic fatalities once again has surpassed the number of homicides in 2024. The number of lives lost from a traffic crash was 307 compared to 268 homicides. In the 20202-2024 California's Strategic Highway Safety Plan, the California Highway Patrol (CHP) implemented the Safe System Approach that identified impaired driving as a high priority challenge area that represents the greatest opportunity to reduce fatalities and serious injury traffic crashes.

Regrettably, the City continues to experience a startling number of crashes in key categories. A review of traffic crash statistics from 2022 revealed several increases in the following categories: suspected serious injury crashes, all injury crashes, all hit and runs crash categories, DUI-fatalities and DUI-suspects serious injury crashes. The only categories not have increased included total fatalities and DUI-injury crashes. The following is a brief overview of the crash statistics:

As depicted above, the total number of fatal and suspected serious injury traffic crashes combined have increased from 1,829 in 2022 to 1,907 in 2024, indicating a concerning upward trend. While the percentage increase might seem modest, even a small rise in these two critical crash categories demands scrutiny, especially considering the impact on families and communities. Identifying the root causes behind this increase is crucial for implementing effective preventive measures.

Moreover, DUI-related crashes, both fatal and non-fatal, have shown a noticeable uptick. DUI-related fatal crashes rose from 19 in 2022 to 22 in 2024, signifying an escalation in the risks associated with impaired driving. Similarly, DUI-related severe injury crashes and injury crashes continue to occur at the same alarming number. This suggests a pressing need for intensified efforts in combating impaired driving, including stricter enforcement and enhanced public awareness campaigns.

The surge in hit-and-run crashes, across all severity levels, is another alarming trend. Hit-and-run traffic crashes have long been considered as possibly DUI related. Hit-and-run fatal crashes increased from 86 in 2022 to 99 in 2024, severe injury hit-and-run crashes increased from 302 in 2022 to 353 in 2024, and all injury crashes increased from 3,317 in 2022 to 3,470 in 2024. Enhancing law enforcement efforts and raising public awareness is imperative to reverse this concerning trend.

In conclusion, the analysis of the 2022 to 2024 traffic crash statistics highlights the pressing need for targeted interventions in addressing the surge in fatal crashes, DUI-related incidents and hit-and-run occurrence accidents. A multifaceted approach involving law enforcement and public awareness is crucial to mitigate these emerging problems and enhance overall road safety.

#### **DUI ARRESTS**

The LAPD has noted the number of drivers arrested for DUI of alcohol and drugs over the past year have continued to exceed 5,000 arrests. Over the past three years, the LAPD has made the following DUI arrest:

2022: 5,4782023: 5,7012024: 5,470

An analysis of arrests made at DUI checkpoints was conducted to determine whether there has been a shift in the number of community members who are being arrested for being under the influence versus drugs/alcohol combination. This type of analysis is good indicator of the type of impaired driver on the roadways in the City. The analysis revealed that community members being arrested for drugs/alcohol combination has dramatically increased from 36% in 2022 to 47% in 2024. The below arrest statistics from checkpoints revealed the following:

#### INSUFFICIENT NUMBER OF DRE-RELATED TRAINED OFFICERS

Although the LAPD has made significant progress over the past three years in providing SFST, ARIDE and DRE training, the total number of personnel trained is still lacking. In the 2014 California's Strategic Highway Safety Plan, the California Highway Patrol (CHP) recommended that law enforcement agencies within California maintain the following training standard for officers to have a meaningful impact with DUI enforcement efforts:

- SFST Recommendation: 100 percent of officers trained in SFST.
   Current Status: Although every LAPD officer receives abbreviated
   (less than eight hours) training in SFST at the Police Academy, only 950 (10.9%) of officers have attended the 24-hour SFST training.
- ARIDE Recommendation: 50 percent of officers trained in ARIDE.
   Current Status: 1,250 (14.3%) of the 8,746 officers have received ARIDE training.

• DRE Recommendation: 10 percent of officers trained in DRE

Current Status: 341 (3.8%) of the 8,746 officers have received DRE training.

# PROPOSED SOLUTION

#### OFFICER TRAINING

The LAPD is fortunate to have the capability to provide all DRE-related training internally. The LAPD currently has a cadre of DRE/SFST instructors who will provide the following training:

Impaired Driver Apprehension Program Course

Using CHP grant funds, the LAPD will present three IDAP Courses. The California Highway Patrol DRE Unit has verified the IDAP Course combines the 24-hour SFST curriculum with the 16-hour ARIDE curriculum. A total of 75 officers will receive SFST training through the IDAP Course. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

Advanced Roadside Impaired Driving Enforcement Course

Using CHP grant funds, he LAPD will present five ARIDE Courses. A total of 200 officers will receive ARIDE training. 75 officers will receive the training through IDAP and an additional 125 through the ARIDE Course. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

Drug Recognition Expert Course

Using CHP grant funds, the LAPD will present two DRE Courses. A total of 30 officers will receive DRE training. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

Drug Recognition Expert Certification Task Forces

Upon completion of the classroom portion of DRE School, students are required to perform 12 DRE evaluations supervised by a DRE instructor within 90 days. To assist the students in achieving this objective, the LAPD conducts DRE Certification Task Forces. The task forces are conducted throughout the City in each bureau where students are likely to locate and identify suspects who are under the influence of a drug. Detained suspects are transported to a command post where a DRE evaluation is conducted by the DRE student in the presence of a DRE instructor. Once the DRE student determines the drug category and the instructor concurs with the evaluation, a blood sample is obtained from the suspect, who is the processed and booked at a LAPD jail.

The task forces must be adequately staffed by DRE instructors and supervisors to ensure there is proper span and control of the LAPD personnel to monitor the students. Using CHP grant funds, the LAPD will conduct five DRE Task Forces to certify the officers who were recently trained as DREs. A total of 30 officers will be certified through the DRE Task Forces. Grant funding will be used to hire the instructors on a cash overtime basis to oversee the DRE evaluations conducted during the task forces.

Additionally, grant funds will be used to contract Phlebotomy Services. To support the task forces, vendor(s) will be contracted to provide phlebotomy services. A phlebotomist will be stationed at the command post of the DRE certification task forces and will perform blood withdraws on suspects arrested by DRE students. The presence of a phlebotomist expedites the booking process of the suspect in lieu of the standard process, which requires the suspect to be taken to one of the LAPD's jail dispensaries or contract hospital for a blood withdraw. The phlebotomist will work a minimum of four hours and a maximum of eight hours at a rate to be determined.

Drug Recognition Expert Recertification Training

Using CHP grant funds, the LAPD will conduct four DRE Recertification Courses. All DREs are required to attend recertification training every two years to maintain their National certification. A total of 80 officers will receive recertification training. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

#### BUSINESS COMMUNITY OUTREACH

Using CHP grant funds, the LAPD will conduct 60 business outreach events where officers will visit marijuana dispensaries with the goal of building rapport, so that the LAPD can provide educational messages to the dispensaries in a positive setting. The dispensaries will be provided educational materials, such as handouts that can be distributed to their customers. The primary focus of the education is to remind community members not to smoke marijuana and drive. If an understanding can be achieved with the dispensary owners that driving while under the influence of marijuana is dangerous and the owners are willing to convey that message to their customers, it will be viewed as a major success.

To date, the business community outreach conducted under 2024/25 CHP Cannabis Tax Fund Law Enforcement Grant has been well received and should be viewed as an immense success. It is proposed that this activity continue with the 2025/2026 CHP CTF grant program.

#### **ENFORCEMENT**

Using CHP grant funds, the LAPD will conduct 10 DUI/DUID Enforcement Task Forces to apprehend drivers under the influence of alcohol, drugs, or a combination of the two. When possible, the task forces will be conducted on identified dates (i.e. April 20th, commonly referred to as 420) and at events prone to the use of cannabis, such as cannabis conventions at the Los Angeles Convention Center, Banc of California Stadium, Shrine and concerts at the Los Angeles Coliseum and Crypto Center.

The task forces will be staffed by three supervisors, 18 officers and three detention officers. Officers assigned to the task force will be paired together and will focus efforts on apprehending drivers who are DUI/DUID. Apprehended drivers will be transported to the command post where the appropriate chemical tests will be administered, and arrested drivers will be booked at one of the LAPD's detention facilities by the detention officers assigned to the task force.

The three supervisors will consist of one officer in charge of the task force and two field supervisors. The officer in charge has ultimate control of the task force and has final say in all operations related to the task force. The two field supervisors will monitor the officers in the field and will address all risk management issues that might arise. The supervision levels meet the LAPD standard for span and control for the task forces.

#### Performance Measures/Scope of Work

The proposed program will focus on DUID enforcement efforts and to increase training that assists officers in detecting and removing impaired drivers from the roadway with an overarching goal of increased training/education, prevention, and the enforcement of laws related to driving under the influence of alcohol and other drugs, including cannabis and cannabis products.

Goal

The following objectives will assist the LAPD in reducing DUI, hit and run, and nighttime-related traffic crashes by five percent.

#### Objectives

- 1. Issue a press release announcing the commencement of the grant
  - Timeline: Completed by August 31, 2025
- 2. Present three SFST courses to train 75 officers
  - Timeline: Q1 = 0, Q2 = 1, Q3 = 1, Q4 = 1
- 3. Present five ARIDE courses to train 125 officers
  - Timeline: Q1 = 0, Q2 = 1, Q3 = 2, Q4 = 2
- 4. Present two DRE courses to train 30 officers
  - Timeline: Q1 = 0, Q2 = 0, Q3 = 1, Q4 = 1
- 5. Present five DRE Certification Task Forces certify 30 officers as DREs
  - Timeline: Q1 = 0, Q2 = 1, Q3 = 2, Q4 = 2
- 6. Present four DRE Re-Certification Courses to re-certify 80 officers as DREs

- Timeline: Q1 = 0, Q2 = 2, Q3 = 1, Q4 = 1
- 7. Present 60 Business Outreach Events
  - Timeline: Q1 = 12, Q2 = 16, Q3 = 16, Q4 = 16
- 8. Present 12 DUI/DUID Enforcement Task Forces
  - Timeline: Q1 = 3, Q2 = 3, Q3 = 3, Q4 = 3
- 9. To secure a contract with a phlebotomy services provider to assist at the DRE Certification Task Forces
  - Timeline: Q1 = Renew and Execute the Contract, Q2 = Utilize Contractual Services, Q3 = Utilize Contractual Services, Q4 = Utilize Contractual Services

Note: During the 2023/24 Cannabis Tax Fund Grant cycle, the LAPD conducted a formal Request to identify and contract with a vendor(s) to provide phlebotomy services at DRE Certification Task Forces. A provision in the contract allows for the identified vendor(s) to be used for up to five years without conducting a new RFP; therefore, there will be no lapse in the use of the phlebotomy vendor(s) upon approval of the grant by the City Council and Mayor.

Goal is to distribute the pen lights at the completion of the DRE and DRE Recertification Schools provided throughout the grant.

• Timeline - Distribution will commence in the 1st Quarter of the Grant Cycle and throughout the grant cycle with 25 lights being distributed each quarter.

# Quantitative Measurements

The goals are to achieve a 5% reduction in DUI and DUID traffic crashes and a 5% increase of DUI and DUID arrests.

# Taskforces Numbers

We have DRE Certification Task Force and the 10 DUI /DUID Task Forces. Task Force is the group of personnel formed for this specific function.

- The LAPD will collect and report data quarterly that supports the progress of goals and objectives.
- Statistical data relating to the grant goals and objectives will be collected, analyzed, and incorporated
  in the Quarterly Reports.
- The LAPD will compare actual grant accomplishments with the planned accomplishments and will
  include information concerning changes made by the Grant Director in planning and guiding the grant
  efforts.

Phase 4 – Final Quarterly Progress Report Within 60 Calendar Days following the Closure of the Grant

Using the data compiled during the grant, the LAPD will complete a Closeout Review with the fourth/final Quarterly Report. The Closeout Review will provide a brief summary of the grant's accomplishments, challenges and significant activities. #### Program Sustainability

The grant augments and supplements existing programs within the LAPD. The funding provided through this grant improves the LAPD's DRE Program by providing funding to DRE Instructors to provide additional training, which will result in additional officers trained in SFST, ARIDE and DRE. Without the funding, the LAPD would continue to provide DRE-related training, but at a decreased rate.

# **Administrative Support**

This program has full support of the City. Every effort will be made to continue the activities after the grant conclusion.

#### Staffing Levels

The LAPD currently has 8,746 sworn personnel with 261 certified DREs and 25 certified DRE Instructors. The officer training will be staffed by DRE instructors, the Business Community Outreach will be staffed by traffic experts and the DUI/DUID Enforcement Task Forces will be overwhelming staffed by personnel that have received SFST, ARIDE or DRE training.

#### **Program and Fiscal Staff Qualifications**

The proposed program will be staffed with a program manager and a grants analyst. The Program Manager, Sergeant Sean Karmody, is the Traffic Group's Grant Coordinator who, over the past 20 years, has managed 38 OTS grants worth approximately \$72 million. During this period, multiple State and internal audits have been performed to ensure proper grant management and no major discrepancies have been identified. An LAPD Grants Analyst will be assigned to the proposed program to submit all financial and progress reports as well as manage all grant administration duties.

The LAPD has been awarded and has successfully managed grants ranging from \$100,000 to \$6,600,000 from various local, state, and federal entities including CHP, OTS and DOJ. The LAPD Grants Section consists of a Grants Manager and six Grants Analysts to oversee and report on over 30 active grants.

The City of Los Angeles (City) continues to be plagued by irresponsible community members who drive while impaired. The number of community members who are driving while under the influence of cannabis has increased substantially. This was the result of the legalization of marijuana for recreational purposes in 2016. Research conducted by the National Highway Traffic Safety Administration (NHTSA) indicates drug prevalence is "on the rise among drivers." A 2020 NHTSA study of seriously or fatally injured road users concluded the overall prevalence of alcohol, cannabis and opioids is on the increase. The Los Angeles Police LAPD (LAPD or LAPD) recognizes that a multi-strategy approach of increased training, community outreach, and enforcement is critical in the battle to confront impaired driving. Through community outreach, enforcement and training, the LAPD has the ability to enact strategies to save lives and increase the safety of all road users in the City of Los Angeles. Together, these strategies will reduce the threat of impaired driving and enhance public safety by ensuring all road users are safe while traveling through the City of Los Angeles.

## PROBLEM STATEMENT

The City has a population of approximately four million community members and covers 468 square miles. Within the City, there are approximately 7,500 miles of street, 11,000 miles of sidewalks, and 40,000 intersections. The City continues to face challenges with community members who are unsafely driving a motor vehicle and driving under the influence.

### TRAFFIC CRASHES

Last year, the LAPD reported that in 2023 the number of traffic fatalities had surpassed the number of homicides for the first time in 50 years. Unfortunately, the number of traffic fatalities once again has surpassed the number of homicides in 2024. The number of lives lost from a traffic crash was 307 compared to 268 homicides. In the 20202-2024 California's Strategic Highway Safety Plan, the California Highway Patrol (CHP) implemented the Safe System Approach that identified impaired driving as a high priority challenge area that represents the greatest opportunity to reduce fatalities and serious injury traffic crashes.

Regrettably, the City continues to experience a startling number of crashes in key categories. A review of traffic crash statistics from 2022 revealed several increases in the following categories: suspected serious injury crashes, all injury crashes, all hit and runs crash categories, DUI-fatalities and DUI-suspects serious injury crashes. The only categories not have increased included total fatalities and DUI-injury crashes. The following is a brief overview of the crash statistics:

As depicted above, the total number of fatal and suspected serious injury traffic crashes combined have increased from 1,829 in 2022 to 1,907 in 2024, indicating a concerning upward trend. While the percentage increase might seem modest, even a small rise in these two critical crash categories demands scrutiny, especially considering the impact on families and communities. Identifying the root causes behind this increase is crucial for implementing effective preventive measures.

Moreover, DUI-related crashes, both fatal and non-fatal, have shown a noticeable uptick. DUI-related fatal crashes rose from 19 in 2022 to 22 in 2024, signifying an escalation in the risks associated with impaired driving. Similarly, DUI-related severe injury crashes and injury crashes continue to occur at the same alarming number. This suggests a pressing need for intensified efforts in combating impaired driving, including stricter enforcement and enhanced public awareness campaigns.

The surge in hit-and-run crashes, across all severity levels, is another alarming trend. Hit-and-run traffic crashes have long been considered as possibly DUI related. Hit-and-run fatal crashes increased from 86 in 2022 to 99 in 2024, severe injury hit-and-run crashes increased from 302 in 2022 to 353 in 2024, and all injury crashes increased from 3,317 in 2022 to 3,470 in 2024. Enhancing law enforcement efforts and raising public awareness is imperative to reverse this concerning trend.

In conclusion, the analysis of the 2022 to 2024 traffic crash statistics highlights the pressing need for targeted interventions in addressing the surge in fatal crashes, DUI-related incidents and hit-and-run occurrence accidents. A multifaceted approach involving law enforcement and public awareness is crucial to mitigate these emerging problems and enhance overall road safety.



### **DUI ARRESTS**

The LAPD has noted the number of drivers arrested for DUI of alcohol and drugs over the past year have continued to exceed 5,000 arrests. Over the past three years, the LAPD has made the following DUI arrest:

- 2022: 5,478
- 2023: 5,701
- · 2024: 5,470

An analysis of arrests made at DUI checkpoints was conducted to determine whether there has been a shift in the number of community members who are being arrested for being under the influence versus drugs/alcohol combination. This type of analysis is good indicator of the type of impaired driver on the roadways in the City. The analysis revealed that community members being arrested for drugs/alcohol combination has dramatically increased from 36% in 2022 to 47% in 2024. The below arrest statistics from checkpoints revealed the following:

- Drugs/Combination 174 224 229

# INSUFFICIENT NUMBER OF DRE-RELATED TRAINED OFFICERS

Although the LAPD has made significant progress over the past three years in providing SFST, ARIDE and DRE training, the total number of personnel trained is still lacking. In the 2014 California's Strategic Highway Safety Plan, the California Highway Patrol (CHP) recommended that law enforcement agencies within California maintain the following training standard for officers to have a meaningful impact with DUI enforcement efforts:

SFST Recommendation: 100 percent of officers trained in SFST.

Current Status: Although every LAPD officer receives abbreviated (less than eight hours) training in SFST at the Police Academy, only 950 (10.9%) of officers have attended the 24-hour SFST training.

• ARIDE Recommendation: 50 percent of officers trained in ARIDE.

Current Status: 1,250 (14.3%) of the 8,746 officers have received ARIDE training.

DRE Recommendation: 10 percent of officers trained in DRE

Current Status: 341 (3.8%) of the 8,746 officers have received DRE training.

### PROPOSED SOLUTION

# OFFICER TRAINING

The LAPD is fortunate to have the capability to provide all DRE-related training internally. The LAPD currently has a cadre of DRE/SFST instructors who will provide the following training:

Impaired Driver Apprehension Program Course

Using CHP grant funds, the LAPD will present three IDAP Courses. The California Highway Patrol DRE Unit has verified the IDAP Course combines the 24-hour SFST curriculum with the 16-hour ARIDE curriculum. A total of 75 officers will receive SFST training through the IDAP Course. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

Advanced Roadside Impaired Driving Enforcement Course

Using CHP grant funds, he LAPD will present five ARIDE Courses. A total of 200 officers will receive ARIDE training. 75 officers will receive the training through IDAP and an additional 125 through the ARIDE Course. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

**Drug Recognition Expert Course** 



Using CHP grant funds, the LAPD will present two DRE Courses. A total of 30 officers will receive DRE training. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

# Drug Recognition Expert Certification Task Forces

Upon completion of the classroom portion of DRE School, students are required to perform 12 DRE evaluations supervised by a DRE instructor within 90 days. To assist the students in achieving this objective, the LAPD conducts DRE Certification Task Forces. The task forces are conducted throughout the City in each bureau where students are likely to locate and identify suspects who are under the influence of a drug. Detained suspects are transported to a command post where a DRE evaluation is conducted by the DRE student in the presence of a DRE instructor. Once the DRE student determines the drug category and the instructor concurs with the evaluation, a blood sample is obtained from the suspect, who is the processed and booked at a LAPD jail.

The task forces must be adequately staffed by DRE instructors and supervisors to ensure there is proper span and control of the LAPD personnel to monitor the students. Using CHP grant funds, the LAPD will conduct five DRE Task Forces to certify the officers who were recently trained as DREs. A total of 30 officers will be certified through the DRE Task Forces. Grant funding will be used to hire the instructors on a cash overtime basis to oversee the DRE evaluations conducted during the task forces.

Additionally, grant funds will be used to contract Phlebotomy Services. To support the task forces, vendor(s) will be contracted to provide phlebotomy services. A phlebotomist will be stationed at the command post of the DRE certification task forces and will perform blood withdraws on suspects arrested by DRE students. The presence of a phlebotomist expedites the booking process of the suspect in lieu of the standard process, which requires the suspect to be taken to one of the LAPD's jail dispensaries or contract hospital for a blood withdraw. The phlebotomist will work a minimum of four hours and a maximum of eight hours at a rate to be determined.

# **Drug Recognition Expert Recertification Training**

Using CHP grant funds, the LAPD will conduct four DRE Recertification Courses. All DREs are required to attend recertification training every two years to maintain their National certification. A total of 80 officers will receive recertification training. Grant funding will be used to hire the instructors on a cash overtime basis to present the courses.

## BUSINESS COMMUNITY OUTREACH

Using CHP grant funds, the LAPD will conduct 60 business outreach events where officers will visit marijuana dispensaries with the goal of building rapport, so that the LAPD can provide educational messages to the dispensaries in a positive setting. The dispensaries will be provided educational materials, such as handouts that can be distributed to their customers. The primary focus of the education is to remind community members not to smoke marijuana and drive. If an understanding can be achieved with the dispensary owners that driving while under the influence of marijuana is dangerous and the owners are willing to convey that message to their customers, it will be viewed as a major success.

To date, the business community outreach conducted under 2024/25 CHP Cannabis Tax Fund Law Enforcement Grant has been well received and should be viewed as an immense success. It is proposed that this activity continue with the 2025/2026 CHP CTF grant program.

### **ENFORCEMENT**

Using CHP grant funds, the LAPD will conduct 10 DUI/DUID Enforcement Task Forces to apprehend drivers under the influence of alcohol, drugs, or a combination of the two. When possible, the task forces will be conducted on identified dates (i.e. April 20th, commonly referred to as 420) and at events prone to the use of cannabis, such as cannabis conventions at the Los Angeles Convention Center, Banc of California Stadium, Shrine and concerts at the Los Angeles Coliseum and Crypto Center.

The task forces will be staffed by three supervisors, 18 officers and three detention officers. Officers assigned to the task force will be paired together and will focus efforts on apprehending drivers who are DUVDUID. Apprehended drivers will be transported to the command post where the appropriate chemical tests will be administered, and arrested drivers will be booked at one of the LAPD's detention facilities by the detention officers assigned to the task force.

The three supervisors will consist of one officer in charge of the task force and two field supervisors. The officer in charge has ultimate control of the task force and has final say in all operations related to the task force. The two field supervisors will monitor the officers in the field and will address all risk management issues that might arise. The supervision levels meet the LAPD standard for span and control for the task forces.

Staffing Levels

The LAPD currently has 8,746 sworn personnel with 261 certified DREs and 25 certified DRE Instructors. The officer training will be staffed by DRE instructors, the Business Community Outreach will be staffed by traffic experts and the DUI/DUID Enforcement Task Forces will be overwhelming staffed by personnel that have received SFST, ARIDE or DRE training.

Program and Fiscal Staff Qualifications

The proposed program will be staffed with a program manager and a grants analyst. The Program Manager, Sergeant Sean Karmody, is the Traffic Group's Grant Coordinator who, over the past 20 years, has managed 38 OTS grants worth approximately \$72 million. During this period, multiple State and internal audits have been performed to ensure proper grant management and no major discrepancies have been identified. An LAPD Grants Analyst will be assigned to the proposed program to submit all financial and progress reports as well as manage all grant administration duties.

The LAPD has been awarded and has successfully managed grants ranging from \$100,000 to \$6,600,000 from various local, state, and federal entities including CHP, OTS and DOJ. The LAPD Grants Section consists of a Grants Manager and six Grants Analysts to oversee and report on over 30 active grants.

# **Event Recorder, Equipment Licenses**

The number of DUI crashes, especially DUI drug crashes, continue to occur at an alarming rate. In addition to evaluating the driver for impairment, the ability to investigate the movement of the vehicle prior to the crash is critical component in the criminal investigation. The City Attorney and District Attorney Offices rely considerably on the crash investigations and often requires that the involved vehicle Event Data Recorders are downloaded before proceeding with criminal filings. The Event Data Recorder is utilized to ascertain the speed of involved vehicles prior to a crash. The LAPD is seeking software licenses and equipment (cables and hardware) that will enable downloads of the following vehicles: Hyundai, KIA, Honda, Subaru, GM, Ferrari, Lucid, VW, Volvo, Daimler, and BMW.
