Every week, I volunteer to speak about this project face-to-face and one-by-one with constituents of the communities that will be impacted as well as people from other parts of Los Angeles, California, and beyond. Some only need to hear "gondola to Dodger Stadium" to know that this project is ill-conceived. Others need to hear more details and see images to understand that this project doesn't have legs to stand on. Hundreds of people every month sign the Stop The Gondola petition because they want the "electeds" to know that they do not support the gondola. They do not support the detrimental impacts to the LA State Historic Park or the impacts to Chinatown, El Pueblo/Olvera Street, and the surrounding communities. They do not support a billionaire's Trojan Horse to enable his development rights to the stadium parking lots. They do not support the claims that this project would actually reduce traffic in the downtown area.
