The CIS process was enabled by the to Los Angeles Administrative Code §Section 22.819. It provides that, "a Neighborhood Council may take a formal position on a matter by way of a Community Impact Statement (CIS) or written resolution." NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

Summary: At a Brown Act Compliant Meeting on February 11, 2026, NoHo NC voted to support the nine above referenced council files, collectively referred to as the "Keep Hollywood Home" motions.

On location filming in LA has dropped a staggering 50% over three years putting thousands of jobs and small businesses in LA at risk. Per the LAEDC, for every \$1 spent on film productions in LA, \$24.40 flows back into labor and local businesses. That's a 2440% ROI our workers and local economy can't afford to lose due to outdated and dysfunctional LA film permitting processes.

This package of nine coordinated motions aims to reduce filming costs, speed up permit approvals, increase transparency in permitting and fees, foster regional coordination, and support workers both in the film industry and in the business community that the film industry supports.
