### **Passage Routes**

The City of Los Angeles has made significant investments to increase the number of interim shelter beds for people experiencing homelessness (PEH) within Council District 11. There is an immediate need to provide safe spaces to unsheltered people living in the public rights-of-way in Council District 11. It is imperative that the areas within 500 ft of the passage routes within this resolution

remain clear of encampments to ensure open, clear and safe public spaces for every person that may wish to pass safely through these communities.

*\*Note: The data provided by LAFD and LAPD is from 7/28/24 - 7/29/25 or, in the case of 100 E Sunset Avenue, 12/31/24 - 4/01/25.*

1) 100 E Sunset Avenue - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 100 E Sunset Avenue, a vital thoroughfare providing coastal access for pedestrians who traverse its sidewalk. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a four month period, the Fire Department reported numerous emergency incidents, including responding to an encampment fire. For this public safety reason, sleeping or lodging within 500 feet of 100 E Sunset Avenue is unsafe, unhealthy, or incompatible with safe passage.

2) 313 E Grand Boulevard - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 313 E Grand Boulevard, a vital thoroughfare providing coastal access for pedestrians who traverse its sidewalk. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Fire Department reported numerous emergency incidents, including responding to an encampment fire. For this public safety reason, sleeping or lodging within 500 feet of 313 E Grand Boulevard is unsafe, unhealthy, or incompatible with safe passage.

3) 370 E Rose Avenue - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 370 E Rose Avenue. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department reported dozens of emergency incidents including assaults and individuals with weapons. For this public safety reason, sleeping or lodging within 500

feet of 370 E Rose Avenue is unsafe, unhealthy, or incompatible with safe passage.

4) 8301 S Lincoln Boulevard - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 8301 S Lincoln Boulevard. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department reported more than 100 emergency incidents, including individuals with weapons. For this public safety reason, sleeping or lodging within 500 feet of 8301 S Lincoln Boulevard is unsafe, unhealthy, or incompatible with safe passage.

5) 11803 Wilshire Boulevard - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 11803 Wilshire Boulevard. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department reported dozens of emergency incidents, including individuals with weapons. For this public safety reason, sleeping or lodging within 500 feet of 11803 Wilshire Boulevard is unsafe, unhealthy, or incompatible with safe passage.

6) Westgate Avenue and Wilshire Boulevard - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at Westgate Avenue and Wilshire Boulevard. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Fire Department reported dozens of emergency incidents, including responding to three encampment fires. For this public safety reason, sleeping or lodging within 500 feet of Westgate Avenue and Wilshire Boulevard is unsafe, unhealthy, or incompatible with safe passage.
