Passage Routes

The City of Los Angeles has made significant investments to increase the number of interim shelter beds for people experiencing homelessness (PEH) within Council District 11. There is an immediate need to provide safe spaces to unsheltered people living in the public rights-of-way in Council District 11. It is imperative that the areas within 500 ft of the passage routes within this resolution

remain clear of encampments to ensure open, clear and safe public spaces for every person that may wish to pass safely through these communities.

1) 11357 Venice Boulevard - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 11357 Venice Boulevard, a vital thoroughfare providing coastal access for pedestrians who traverse its sidewalk. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Fire Department reported numerous emergency incidents, including responding to several encampment fires. For this public safety reason, sleeping or lodging within 500 feet of 11357 Venice Boulevard is unsafe, unhealthy, or incompatible with safe passage.

2) 5744 West Manchester Avenue - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 5744 West Manchester Avenue, a vital thoroughfare for pedestrians. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Fire Department reported several emergency incidents, including responding to overdoses. For this public safety reason, sleeping or lodging within 500 feet of 5744 West Manchester Avenue is unsafe, unhealthy, or incompatible with safe passage.

3) 5844 West Manchester Avenue - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 5844 West Manchester Avenue. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department reported emergency incidents including domestic disputes, overdoses, and several instances of trespassing. For this public safety reason, sleeping or lodging within 500 feet of 5844 West Manchester Avenue is unsafe, unhealthy, or incompatible with safe passage.

4) 8448 Lincoln Boulevard - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 8448 Lincoln Boulevard. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department reported dozens of emergency incidents, including overdoses and numerous instances of battery. For this public safety reason, sleeping or lodging within 500 feet of 8448 Lincoln Boulevard is unsafe, unhealthy, or incompatible with safe passage.

5) Intersection of Venice Boulevard & McLaughlin Avenue - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at the intersection of Venice Boulevard & McLaughlin Avenue. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department reported dozens of emergency incidents and the Fire Department responded to numerous encampment fires. For this public safety reason, sleeping or lodging within 500 feet of the intersection of Venice Boulevard & McLaughlin Avenue is unsafe, unhealthy, or incompatible with safe passage.

6) 13477 Beach Avenue - Public Safety

- a) For a year, numerous individuals have consistently maintained an encampment at 13477 Beach Avenue. The sidewalk is often obstructed and poses a public safety issue for housed and unhoused residents alike. Over a 12 month period, the Police Department and the Fire Department each reported dozens of emergency incidents, including responding to several encampment fires. For this public safety reason, sleeping or lodging within 500 feet of 13477 Beach Avenue is unsafe, unhealthy, or incompatible with safe passage.
