Re: Council File:

Pursuant to §41.18(c) of the Los Angeles Municipal Code, the following locations have been identified as areas where the continued sitting, sleeping, lying, storing of personal property, or otherwise obstructing the public right-of-way creates barriers to safe access and public use of these spaces.

The following locations have experienced serious public safety issues, as documented by either the Los Angeles Police Department, or the Los Angeles Fire Department, or both over a 12-month period from July 2024 - July 2025:

### Sepulveda Boulevard and the 10 Freeway (Overpass)

(4) incidents reported by LAPD, and (14) incidents of fires reported by LAFD.

Westwood Boulevard and Olympic Boulevard (Public Safety)

(1) incident reported by LAPD, and (2) fires reported by LAFD.

Pico Boulevard at Prosser Avenue (Public Safety)

(5) incidents of fire reported by LAFD.

Pico Boulevard at Patricia Avenue (Public Safety)

(13) incidents reported by LAFD.

Cotner Avenue and Missouri Avenue (Public Safety)

(7) incidents reported by LAPD, and (6) incidents of fire reported by LAFD.

Cotner Avenue and La Grange Avenue (Public Safety)

(1) incident reported by LAPD, and (1) incident of fire reported by LAFD.

**Cotner Avenue and Mississippi Avenue (Public Safety)** 

(1) incident reported by LAPD, and (2) incidents of fires reported by LAFD.

Outreach teams have previously conducted engagement at these sites, and in some cases, individuals who had been living in encampments have already been connected to housing, including interim housing and motel placements secured through coordination with the Mayor's Office, service providers, and the Los Angeles Homeless Services Authority (LAHSA). Housing has been identified for the individuals currently living at these locations as of the date of this





letter. This resolution is being introduced to maintain safe access to these sensitive public spaces and prevent the return of encampments.

To ensure these locations remain accessible, functional, and safe for their intended use, a designating resolution is required for this location to be effective for a period of one year.


