**DISCUSSION**

This donation will provide funding to Office of Operations to purchase drones, drone docking stations, and the installation of power and internet at selected Department facilities to enable drone operations. The Drone as First Responder program (DFR) deploys drones with high-definition and thermal imaging to reach emergency scenes before ground units. Live video gives officers real-time awareness to assess threats, locate suspects, identify hazards, and at times resolve calls without direct contact. Approval of this donation will improve response times and provide better situational awareness. DFR enhances officer safety, enables more informed decision making, supports de-escalation efforts, and advances the Department’s use of modern technology. Below is a list of items to be donated, along with their estimated value.

**NAME OF REQUEST: DRONE AS FIRST RESPONDER PROGRAM**

The Office of Operations requests approval for a non-restricted donation from the Los Angeles Police Foundation valued at \$21,000,000.00. This donation will support the purchase of drones, drone docking stations, and the installation of power and internet at selected Department facilities to enable drone operations.

Since June 2025, the Office of Operations has piloted the Drone as First Responder (DFR) program, evaluating its feasibility while testing multiple vendors, equipment platforms, personnel, and deployment sites. The pilot has been highly successful, and the Office of Operations has identified the optimal vendor, Skydio Inc., and locations for drone docks to deliver DFR coverage across as much of the current airspace restrictions will allow within the Los Angeles Police Department's 21 geographic areas.

The DFR program deploys drones with high-definition and thermal imaging to reach emergency scenes before ground units. Live video gives officers real-time awareness to assess threats, locate suspects, identify hazards, and at times resolve calls without direct contact.

By improving response times and providing better situational awareness, DFR enhances officer safety, enables more informed decision making, supports de-escalation efforts, and advances the Department's use of modern technology.

The following are the proposed locations for installation of drone docking stations:

With a 2-3 mile operating radius from the above rooftop locations, LAPD drones will support select areas within the following geographic bureaus:

The Office of Operations is also purchasing two (2) stand-alone drones for Mobile DFR operations, a platform that provides the ability to conduct drone operations anywhere in the City, rather than being limited to fixed rooftop locations. Mobile DFR is a critical tool for addressing emerging crime trends, special problems and events.

As the Department works with the FAA to secure waivers for currently restricted airspace, DFR operations will expand accordingly, with the ultimate goal of achieving city-wide coverage across all 21 geographic areas.

The donation in addition to \$1.8 million from the "Retail Theft Grant," will fund toward a three-year contract that includes equipment, warranty coverage and service. Prior to the expiration of the three-year contract, the Department intends to seek future funding through the City budget.

Although there has been expressed interest from Council Districts in contributing to the program's advancement, no dedicated funding has been committed to date.

The Information Technology Bureau (ITB) has been part of the DFR Working Group since its inception and has played a critical role in integrating the technology systems necessary to support compatibility with Skydio and the overall DFR program. All Department technical support will be provided by ITB, while product repairs, updates, and technical support specific to the equipment will be handled directly by Skydio.
