

ORDINANCE NO. 188921

An ordinance dedicating, accepting, and establishing as part of 98th Street certain real property owned by the City of Los Angeles from Sepulveda Boulevard to Vicksburg Avenue, all public streets of the City.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The Council of the City of Los Angeles hereby finds and determines that the public interest, convenience, and necessity require an easement for public street purposes over City-owned real property described and depicted respectively in Exhibits A and B below. Accordingly, such real property is hereby dedicated, accepted, and established as part of 98th Street, a public street of the City.

Sec. 2. Pursuant to Section 252 of the Charter of the City of Los Angeles, this ordinance shall become effective upon publication

Roadway Easement

That portion of Lot 15 of Tract No. 12365, in the City of Los Angeles, County of Los Angeles, State of California, as per map recorded in Book 238, Pages 49 and 50 of Maps, in the office of the County Recorder of said County, described as follows:

BEGINNING at the westerly terminus of that certain course shown as having a bearing of North 89°49'05" West and a length of 574.97 feet in the northerly line of 98th Street, shown on a map filed in Book 301, Pages 21 through 42 of Records of Survey, in the office of the County Recorder of said County;

thence along said certain course, South 89°49'05" East 574.97 feet to the easterly terminus of said certain course;

thence North 45°09'48" East 4.24 feet to a line that is parallel with and 3.00 feet northerly of said certain course;

thence along said parallel line, North 89°49'05" West 568.27 feet;

thence leaving said parallel line, North 44°50'18" West 19.32 feet;

thence South 88°06'21" West 11.05 feet to the westerly line of Sepulveda Boulevard, 60.00 foot half width, as shown on said Tract No. 12365;

thence along said westerly line, South 00°08'29" West 1.26 feet;

thence South 44°50'18" East 21.22 feet to the **POINT OF BEGINNING**.

Containing 1,904 square feet, more or less.

Shown graphically on Exhibit B, attached hereto and made a part hereof.

Bearings and distances used in the above description are based on California Coordinate System (CCS), Zone 5, NAD 83, Epoch 2010.00. Divide distances shown by 1.00001924 to obtain ground level distances.

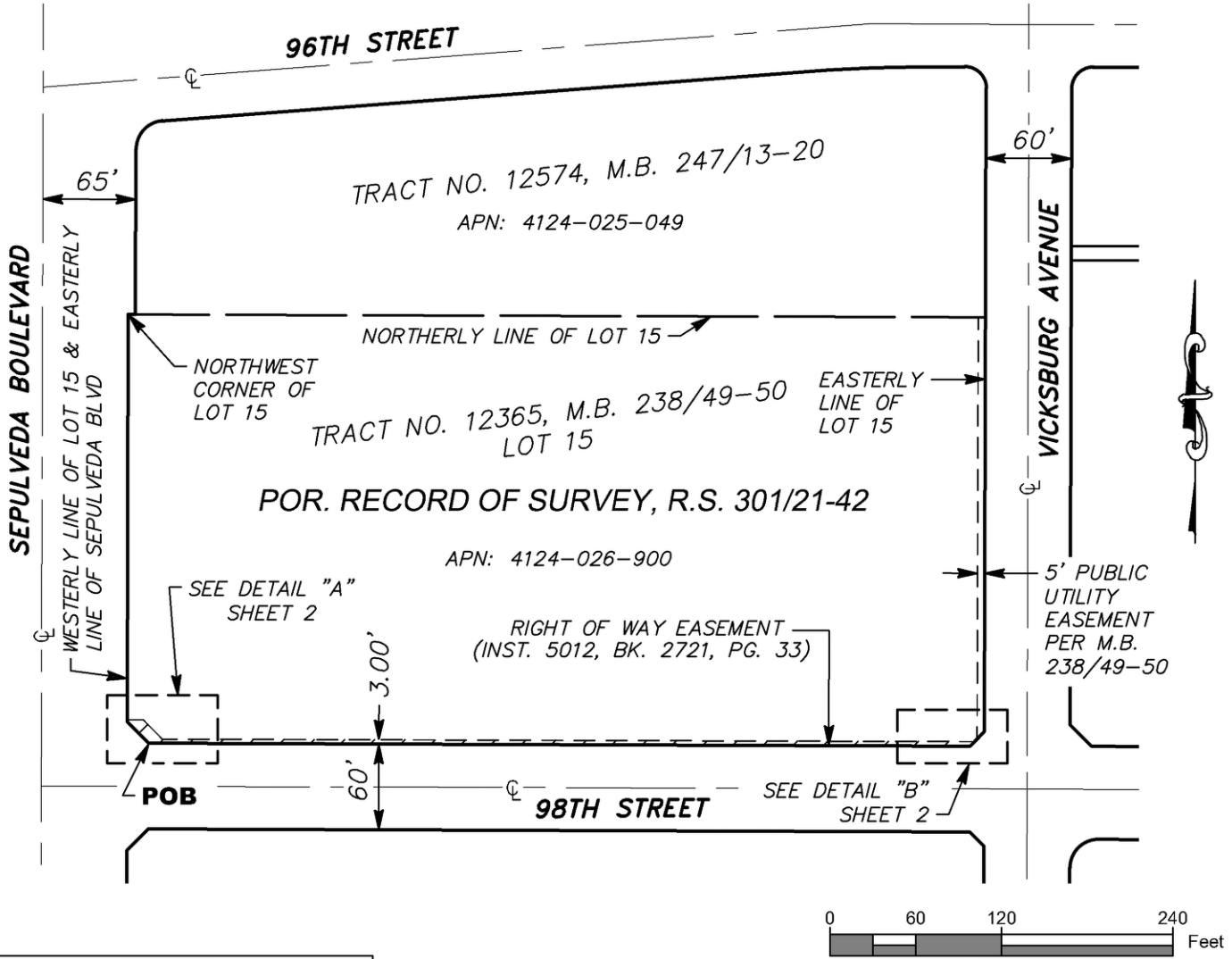

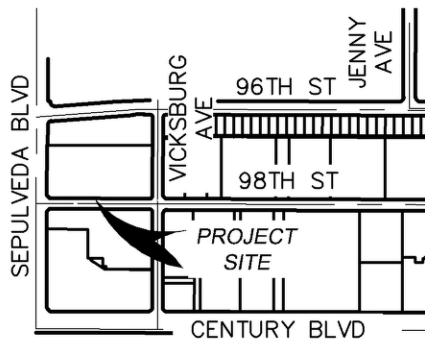

NOT TO SCALE

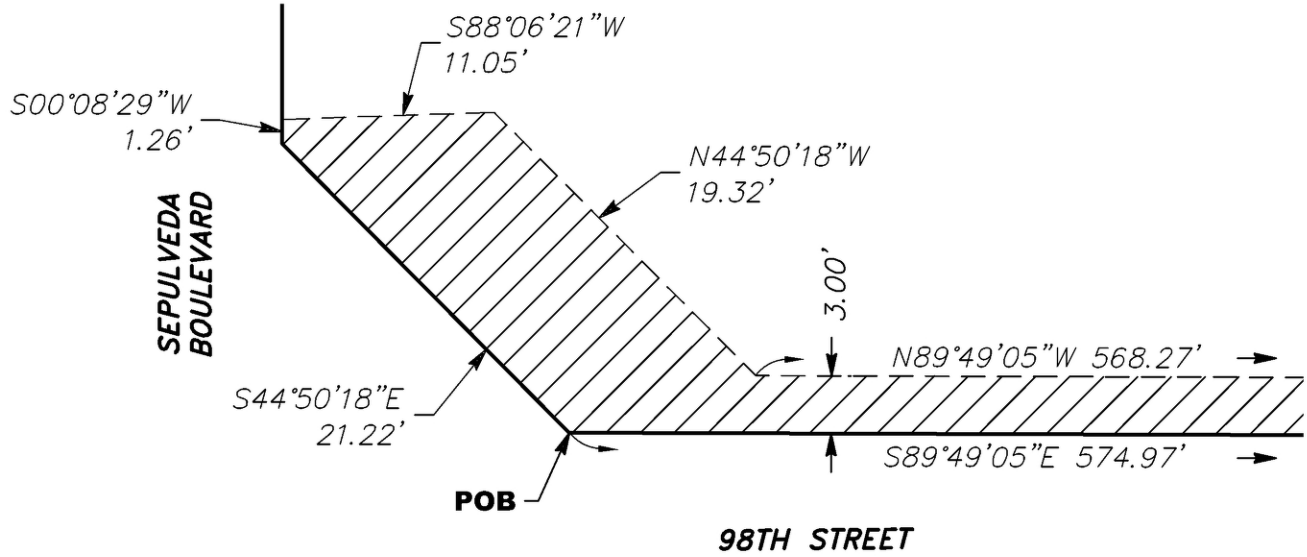

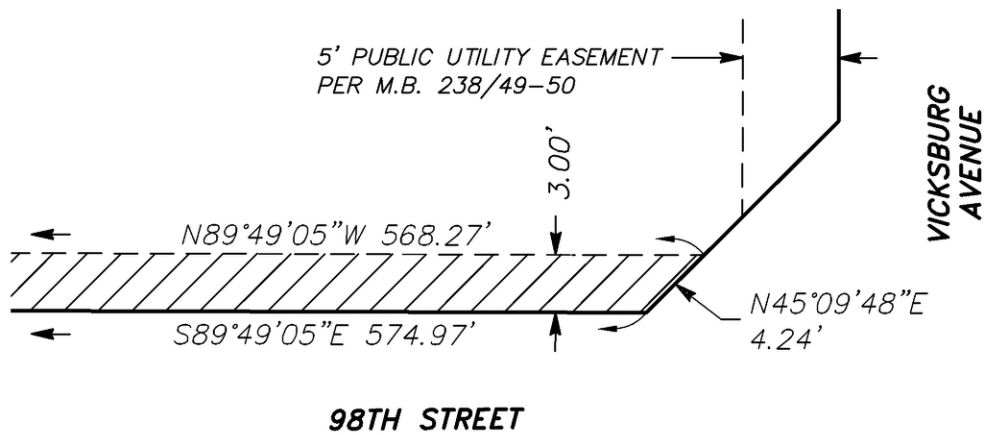

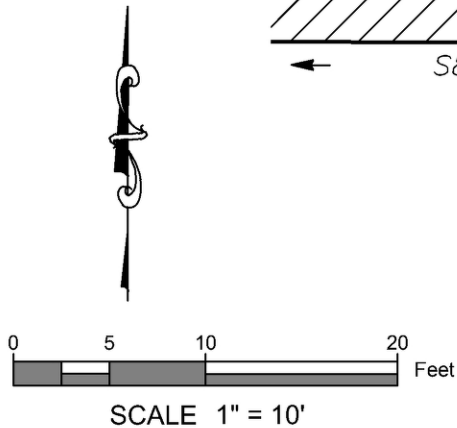
