RE: LAHD COMMENTS ON THE FISCAL YEAR 2026-2027 PROPOSED BUDGET

The Los Angeles Housing Department (LAHD) appreciates the opportunity to respond to the Mayor's Fiscal Year 2026-2027 Proposed Budget (Proposed Budget). LAHD's core mission is to produce and preserve affordable housing in Los Angeles, ensuring that this housing is maintained in a safe, healthy, and financially viable manner, and to support Angelenos in becoming and remaining stably housed.

The Proposed Budget continues funding for critical LAHD programs and allows LAHD to continue providing services deeply needed by Angelenos. This enables LAHD to continue to urgently house Angelenos and keep them housed in alignment with the Mayor's priorities. The Proposed Budget represents a critical investment in LAHD's ability to sustain the City's affordable housing portfolio and ensures robust tenant protections.

Driving affordable housing production, preservation, homeownership, and homelessness prevention efforts is United to House LA (ULA), and we are grateful for the 67 positions provided, which will enable LAHD to launch and expand the eleven ULA programs. This includes the continuation of 44 positions and the addition of 23 new positions, all fully funded by ULA, a special fund. The new ULA positions are in addition to the shift of existing resources from the Proposition HHH program to ULA-funded programs reflected in the Proposed Budget as add/deletes in our Development Finance and Technical Services Divisions. By including a dedicated set-aside of ULA funding for Administration, ULA has provided the City with both the resources and the responsibility to adequately staff the implementing departments so that the intent of ULA can be

realized. The new positions will provide the resources necessary to sustain and grow ULA-funded programming, as mandated by the voters. This includes critical support as LAHD moves forward with funding projects awarded in the recent Homes for LA Notice of Funding Availability (NOFA) and prepares for future NOFA rounds, which will provide additional opportunities for new affordable housing construction, preservation, and operating assistance.

Additionally, we appreciate the continuation of the 10 positions that were recently approved for the new Bureau of Homelessness Oversight. This will provide critical leadership for the new Bureau and add necessary capacity to support existing contracting responsibilities, data analysis, and homelessness policy efforts.

As you know, LAHD is primarily grant and fee-funded, which reduces the impact on the City's General Fund. Nevertheless, the Proposed Budget includes the deletion of one position in the Regulatory Code and Compliance Bureau currently held by a Program Assistant. The position was previously vacant when the initial Budget was submitted, but has since been filled with a long-term employee of the Department. This exempt employee is not eligible for transfer to a civil service position in the Department, and no other exempt positions are vacant. Therefore, the elimination of this position will result in a potential layoff. As such, we respectfully request that this position be reinstated to avoid a potential layoff.

Conclusion

LAHD understands the balance between being fiscally responsible and providing Angelenos with much-needed services. To that end, we appreciate the opportunity to maintain our current level of service for the Homelessness Bureau and expand the level of service for ULA-funded programs across our Bureaus and continue producing, protecting, and preserving housing in the City of Los Angeles.

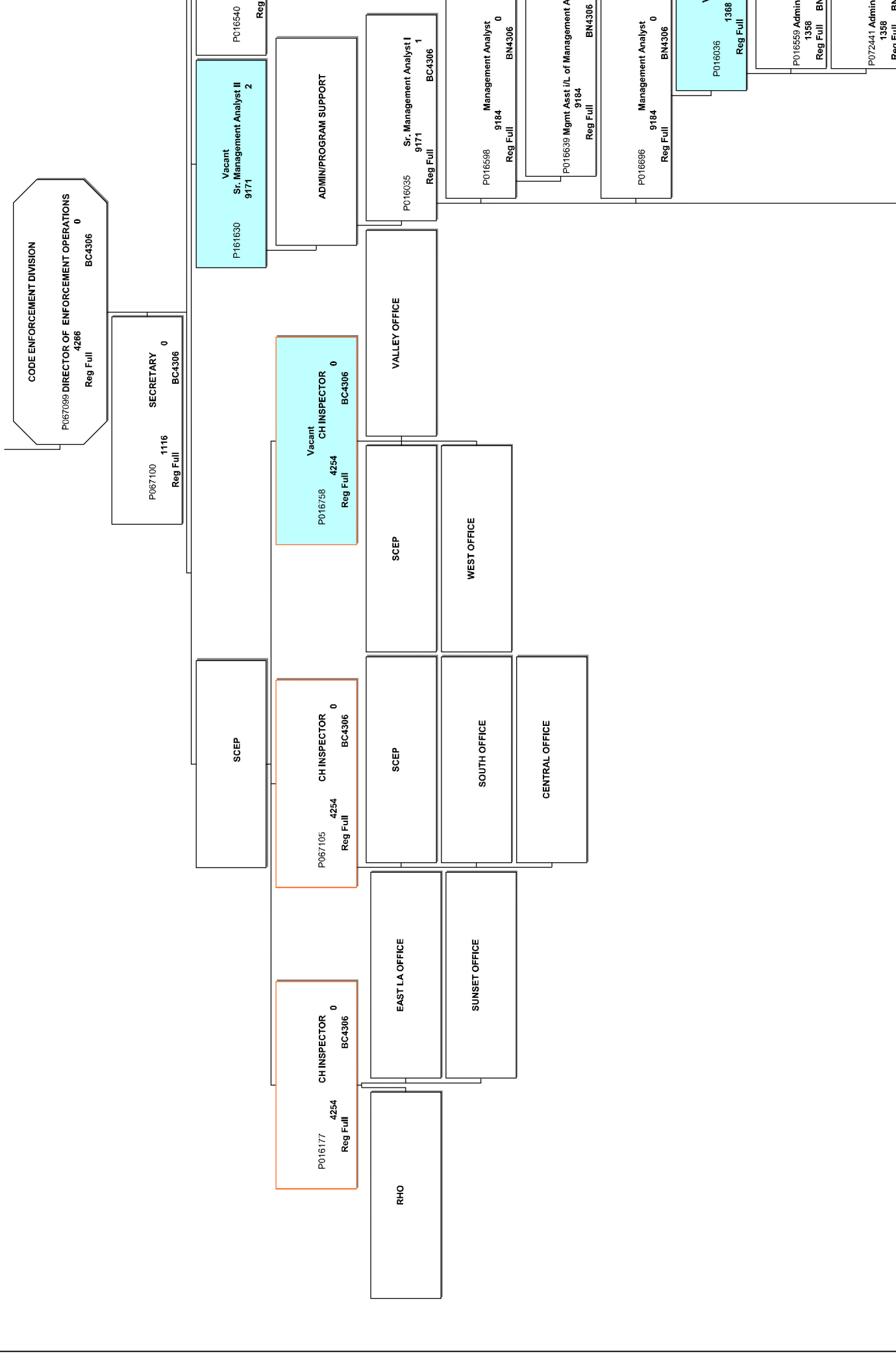

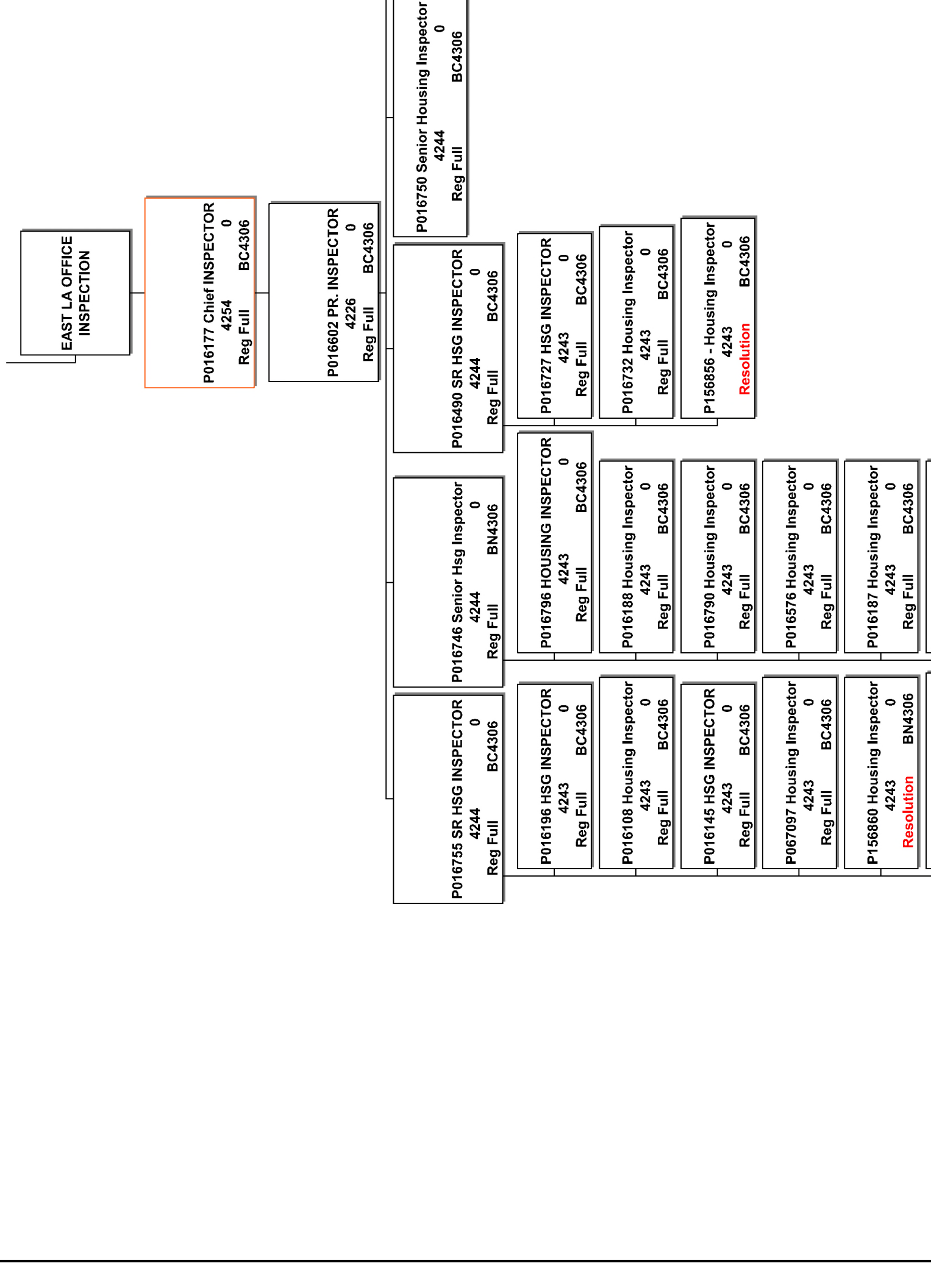
