NCs representatives also testify before City Boards and Commissions on the item related to their CIS. If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or resolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website. Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Council's rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

1. CALL TO ORDER

President Lisa Chapman called the meeting to order at 7:09 p.m. Board members in attendance were Marcy Agmon, Connie Boukidis, Sandy Brown, Lisa Chapman, Roozbeh Farahanipour, Tracey Fitzgerald, Philip Gabriel, Samantha Goldstein, Ann Hayman, Stephen Resnick, Chris Schroeder, Scott Shelton, Michael Telerant and Laura Winikow. Member excused was Stephen Cropper.

2. ANNOUNCEMENTS

DONE NEA Erica Gatica-Doughty thanked Lisa Chapman for her 16 years of service and presented her with a certificate from DONE. CD5 Field Deputy Patricia Macias thanked Lisa and presented her with a plaque from the City. 3rd District County Supervisor Lindsey Horvath's representative Amanda Laflin thanked Lisa and presented her with a certificate from Supervisor Horvath. State Senator Ben Allen's representative Samantha Gallegos thanked Lisa and presented her with a certificate from Senator Allen. UCLA representative Marco Perez thanked Lisa and presented her with a framed letter from Chancellor Julio Frenk and a bag of swag. Chris Schroeder presented Lisa with a cake from Belmont Village.

Samantha Goldstein asked for volunteers for CicLAvia.

3. APPROVAL OF MINUTES

4. COMMENTS BY PUBLIC OFFICIALS

A. U.S. Congressman Ted Lieu's representative Janet Turner thanked Lisa Chapman and gave a legislative update.

B. 3rd District County Supervisor Lindsey Horvath's representative Amanda Laflin gave a legislative update and mentioned a report on mental health.

C. LAFD Battalion Chief Shin Black from Station 37 thanked Lisa Chapman for her service and announced that Station 37 is having a pancake breakfast on May 9th from 9 a.m. to noon and Station 71 is having a pancake breakfast on May 16th.

D. State Senator Ben Allen's representative Samantha Gallegos gave a legislative update and announced that April is Arts, Culture, and Creativity Month.

E. UCLA representative Marco Perez announced that they are proud of the UCLA women's basketball team for winning the NCAA championship and enumerated upcoming events at UCLA. The SAFE Center is opening on May 3rd.

F. CD5 Field Deputy Patricia Macias announced that option 1C was passed for SB79, said Wilshire Blvd. is a priority for speed cameras, April 26th is CicLAvia, and discussed temporary bus lanes for the Olympics.

Roozbeh Farahanipour, Ann Hayman, Stephen Resnick and Laura Winikow recused themselves and left the room. Tracey Fitzgerald moved, "WWNC will award up to \$5,000 to the Friends of the Westwood Library." Marcy Agmon seconded and the motion carried unanimously.

10. PROPOSED HISTORIC-CULTURAL MONUMENT FOR FOX APARTMENTS

A. Discussion and introduction of motion to support monument status for the Fox Apartments, Located at 10251-10257 West Santa Monica Blvd./1749-1755 South Ensley Avenue, Los Angeles, CA 90024

"Whereas, the Fox Apartments, built in 1925 in the early days of Westwood at 10251-10257 West Santa Monica Boulevard and 1749-1755 South Ensley Avenue, was nominated by the Los Angeles Conservancy as a Historic-Cultural Monument (HCM) in the City of Los Angeles; and Whereas, in 1922 the Janss Investment Corporation, led by brothers Edwin and Harold Janss, acquired the 3,300 acre Wolfskill Ranch from the Letts Estate, and soon thereafter announced they would develop "The Second Hollywood," inspired by the successful development of the original Hollywood and the fledgling motion picture industry; and

Whereas, in May 1923 newspapers announced that Fox Film Corporation, led by Studio founder William Fox, had purchased 450 acres spanning from Santa Monica Boulevard to Pico

Boulevard from the Janss Investment Corporation and would develop "Fox Movietone City," the world's first master-planned and purpose-built movie studio built for sound, including the first soundproof stages ever designed, which would be the world's largest Talking Picture plant; and

Whereas, Fox Studios built its ceremonial Front Gate in a magnificent Spanish Colonial Revival design on Santa Monica Boulevard, directly across from the Fox Apartments site, and celebrated its Opening Day Dedication of the Fox Studio backlot on October 28, 1928; and

Whereas, in touting the multi-million dollar investment of the new "Fox Movietone City," the Janss Corporation noted that "hundreds of workers are to be regularly employed" and since "a

great number of Motion Picture Studio employees are essentially 'renters' it is not difficult to foresee the effect this project should have on adjacent income lots"; and

Whereas, Fox Apartments was developed in 1925 across from the Fox Studio Front Gate in a classic streetcar design, as a two-story, vernacular, mixed-use commercial building with ground floor storefronts and display windows, and modest second story studio and bachelor apartments perfect for Studio employees, and known as the Fox Apartments since 1936, along the Pacific Electric Railway route on Santa Monica Boulevard that became part of "Historic Route 66," and Whereas, in the late 1920s and 1930s, the building's commercial storefronts as well as some of the second-floor residential units, were used as offices by real estate companies and brokers who sold lots in the adjacent Janss Investment Company residential development of Westwood Hills, a portion of which is now known as Comstock Hills; and

Whereas, in its 101-year history the Fox Apartments has been home to several significant ground floor businesses, including a neighborhood market and General Store in the 1920s and 30s, and three iconic Legacy Businesses cherished in the Westwood and Comstock Hills communities including famed Emil's Swiss Pastry from 1960 through 2005, Johnnie's New York Pizzeria from 1994 through the present day, and beloved Clementine Bakery & Cafe from 2000 to the present day, during which time this charming red brick building has served as a treasured neighborhood and community gathering place for more than 100 years; and

Whereas, acclaimed baker Emil Hug, founder of Emil's Swiss Pastry, lived with his wife Violeta on Ensley Avenue in the Comstock Hills neighborhood for decades, just blocks from his eponymously named bakery, and where his widow still lives in the family home today; and Whereas, Minnesota native and culinary trained and expert Pastry Chef Annie Miler also moved with her husband David to the Comstock Hills neighborhood in 2005, where she raised

her family and served as President of the Fairburn Avenue PTA, and where she founded her iconic Clementine Bakery & Cafe in 2000, where she could walk to work each day and lead her acclaimed bakery and restaurant that, for 26 years, has served as the sidewalk cafe "living room" for countless Comstock Hills and Westwood neighbors and Century City executives; and Whereas, during the building's 101 year life, the several property owners have thoughtfully maintained and sensitively repaired the red brick structure from any damage resulting from earthquakes and ordinary wear and tear, including an appropriate seismic upgrade and rehabilitation, and sensitive repairs and replacement of damaged materials, in accordance with building's original architectural design and the Secretary of the Interior's standards; and

Whereas, the City's "Survey L.A." found in May 2014 that as the Fox Apartments was a "rare example of early commercial development located along a former streetcar line in Westwood," of which "few examples of this type from this period remain," it appeared eligible for designation as a City Historic-Cultural Monument, as well as for inclusion on the California Register of Historic Resources and the National Register of Historic Places, the official Federal list of the districts, sites, buildings, structures, and objects significant in American history, architecture, archaeology, engineering, and culture that are worthy of preservation; and Whereas, the Fox Apartments "exemplify significant contributions to the broad cultural, economic or social history of the nation, state, city, or community" as a rare example of 1920s commercial development along a former streetcar line in Westwood, of which precious few examples of this property type remain from this period; and

Whereas, the Fox Apartments also "embody the distinctive characteristics of a style, type, period, or method of construction" as a rare example of the multi-story, mixed-use residential and commercial property type developed along a former streetcar line:

Now, therefore, be it resolved that the Westwood Neighborhood Council strongly supports the nomination of the Fox Apartments by the Los Angeles Conservancy and the Recommendation Report of the Office of Historic Resources (OHR) which urges the Cultural Heritage Commission to declare the 1925 Fox Apartments in Westwood as a Historic-Cultural Monument

in the City of Los Angeles; and

Be it finally resolved that we urge the Cultural Heritage Commission, Councilwoman Katy Yaroslavsky, the Los Angeles City Council, and Mayor Karen Bass to support this highly worthy designation of this cherished historic landmark in our Westwood community and the City of Los Angeles.” Lisa Chapman amended the motion. Connie Boukidis moved to approve the above amended motion, seconded by Ann Hayman, and carried unanimously. A letter of support will be requested from Councilmember Yaroslavsky.

WHEREAS, outreach materials such as flyers, signage, and promotional items are necessary to effectively communicate with stakeholders and increase community participation;

NOW, THEREFORE, BE IT RESOLVED, that the WWNC hereby approves expenditures for outreach and promotional materials as follows:

An amount not to exceed \$800 for the design, production, and printing of flyers, as well as poster board materials and related supplies; and

An amount not to exceed \$1,200 for the purchase of promotional items, including metal pens;

An amount for Bryan Coopersmith Design;

BE IT FURTHER RESOLVED, that such expenditures shall be made in accordance with WWNC policies and procedures and subject to the availability of funds.”

The motion was amended to include Bryan Coopersmith Design. Marcy Agmon moved the above motion, seconded by Samantha Goldstein, and carried unanimously.

Pens will be blue with WWNC’s logo and possibly the website also. Marcy has a WWNC banner.

Connie Boukidis was nominated by Lisa Chapman. Tracey Fitzgerald was nominated but declined. Lisa Chapman moved to approve Connie Boukidis as President Elect, seconded by Marcy Agmon and approved unanimously.

Lisa Chapman nominated Marcy Agmon. Lisa moved to appoint Marcy as Homelessness Chair,

seconded by Ann Hayman and approved unanimously.

15. SELECTION OF WWNC WRAC REPRESENTATIVE

Connie Boukidis was nominated. Lisa Chapman moved to appoint Connie Boukidis as WWNC's WRAC representative, seconded by Ann Hayman, and approved unanimously. No alternates were selected.

16. SELECTION OF WWNC WRAC HOMELESSNESS COMMITTEE

Marcy Agmon was nominated. Lisa Chapman moved to appoint Marcy Agmon as WWNC'S WRAC Homelessness representative on the committee, seconded by Laura Winikow and approved unanimously.

Stephen Resnick gave a report. Park rangers were at the park to speak to people who live in RVs.
