

SECOND AMENDMENT TO ISDA MASTER AGREEMENT

This **SECOND AMENDMENT TO ISDA MASTER AGREEMENT** (this “**Amendment**”) is dated January 21, 2026, and made between **MACQUARIE ENERGY LLC** (“**Macquarie**”) and **CITY OF LOS ANGELES ACTING BY AND THROUGH THE DEPARTMENT OF WATER AND POWER** (the “**Counterparty**”) (Macquarie and Counterparty shall be collectively referred to as the “**Parties**”).

WHEREAS, Counterparty and Macquarie are parties to that certain ISDA Master Agreement dated as of March 16, 2007 (as supplemented and/or amended previously, the “**ISDA Master Agreement**”); and

WHEREAS, the Parties desire to amend the ISDA Master Agreement as set forth herein.

NOW THEREFORE, in consideration of the mutual covenants and promises of this Amendment, the parties hereto agree as follows:

I. AMENDMENT

With effect on and from the date of this Amendment, the ISDA Master Agreement is amended as follows:

- (1) Part 4(a) of the Schedule to the ISDA Master Agreement is amended by deleting “Address for notices or communications to Party A” in its entirety and replacing it with the following: “Address for notices or communications to Party A:

- (2) Part 4(g) of the Schedule to the ISDA Master Agreement is amended by deleting “Macquarie Bank Limited” and replacing it with “Macquarie International Finance Limited”.

II. MISCELLANEOUS

(1) **Entire Agreement.** This Amendment constitutes the entire agreement and understanding of the parties with respect to its subject matter and supersedes all oral communications and prior writings with respect thereto.

(2) **Definitions.** All capitalized terms used in this Amendment (but not defined herein) shall have the same meaning ascribed to them in the ISDA Master Agreement.

(3) **Agreement Continuation.** The ISDA Master Agreement, as modified herein, shall continue in full force and effect, and nothing herein contained shall be construed as a waiver or modification of existing rights under the ISDA Master Agreement, except as such rights are expressly modified hereby.

(4) **Representations.** Each party represents and warrants that its execution, delivery and performance of this Amendment has been duly authorised and that this Amendment constitutes its legal, valid and binding obligations. Each party acknowledges that it receives good consideration under or for this Amendment. Each party represents to the other party that all representations contained in the ISDA Master Agreement are true and accurate as of the date of this Amendment and that all such representations are deemed to be given or repeated by each party, as the case may be, on the date of this Amendment.

(5) **Counterparts.** This Amendment may be executed in one or more counterparts, and by the Parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. The Parties further agree that facsimile signatures or signatures scanned into .pdf (or signatures in another electronic format designated by Counterparty) and sent by e-mail shall be deemed original signatures.

(6) **Notices.** Any notice or other communication in respect of this Amendment will be governed by the terms of Section 12 of the ISDA Master Agreement.

(7) **Governing Law.** This Amendment is governed by the laws of the State of New York. With respect to this Amendment, each party submits to the jurisdiction of the courts of the State of New York in accordance with Section 13(b) of the ISDA Master Agreement.
