

ORDINANCE NO. 188972

An ordinance amending Schedule "A" of Section 4.61 of the Los Angeles Administrative Code to include and provide salaries for the new, non-represented classifications of Accountant Assistant and Director of Environmental Management.


Sec. 12. Section 11 shall be operative on July 1, 2028.
