ORDINANCE NO. 189029

An ordinance amending the General Managers listing in Section 4.61 of the Los Angeles Administrative Code, in accordance with the Executive Employee Relations Committee action on May 19, 2026, to revise the salary range designation for the classification of General Manager Community Investment for Families Department from Salary Range "M-8" to Salary Range "M-9."

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. The General Managers listing in Section 4.61 of the Los Angeles Administrative Code is amended to revise the salary range designation for the classification of General Manager Community Investment for Families Department from Salary Range "M-8" to Salary Range "M-9" as follows:

<u>Class Code</u>	<u>Class Title</u>	<u>Salary Range, Amount, MOU No., or Ordinance No.</u>
9277	General Manager Community Investment for Families Department	M-9

Sec. 2. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g). Notwithstanding the effective date, the revision of the salary range designation in Section 1 shall be applied retroactively as if it were operative on September 21, 2025. In addition, all previously adopted ordinances with operative dates after September 21, 2025 that set the salary range for the General Manager Community Investment for Families Department class position in the General Managers listing in Section 4.61 of the Los Angeles Administrative Code are hereby superseded as to that class position.

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
